Acknowledgements

Rates/Taxes & Special Requests

To take advantage of the special AAEA convention rates, please book your reservation by **July 3, 2007**. After that date, room blocks will be released and hotels may charge higher rates.

All rates are per room and do not include 12.5% occupancy tax (subject to change).

Special requests can not be guaranteed, however hotels will do their best to honor all requests. Hotels will assign specific room types upon check-in, based on availability.

Changes & Cancellations
