

INSTRUCTIONS FOR SUBMISSION OF PAPERS TO AGECON SEARCH

Selected Papers:

All accepted Selected Papers must be submitted to *AgEcon Search* by May 1, 2008, or they will be withdrawn from the Joint Annual Meeting.

Selected Posters:

All accepted Selected Posters have the option of submitting their research to AgEcon Search (in either paper or poster format), but it is not required. There is no submission deadline for Selected Posters.

PLEASE FOLLOW THESE STEPS FOR SUBMITTING YOUR PAPER

1) COVER PAGE: Each paper must have a cover page which includes the following information:

- **title of the paper**
- **author(s) name,**
- **affiliation of the author(s)**
- **name of the conference.**

A sample cover page is attached. We suggest that you include a copyright statement at the bottom of the cover page. You, as author of the paper, retain the copyright of the paper. The following is a sample copyright statement that you may use or adapt for your paper.

Copyright 2008 by [authors(s)]. All rights reserved. Readers may make verbatim copies of this document for non-commercial purposes by any means, provided that this copyright notice appears on all such copies.

2) FORMAT: The papers and posters on AgEcon Search are posted in PDF format.

Name your file with the ID number assigned by AAEA (i.e. 11897). Be sure to review the PDF file you have created before sending it to verify that text and formulas have transferred correctly. Please, do not submit a word document to *AgEcon Search*. If you are not able to prepare a PDF file or to use the online submission form, please send your file as an e-mail attachment to Louise Letnes at: lletnes@umn.edu.

3) SUBMISSION: Go to AgEcon Search (<http://ageconsearch.umn.edu/password-login>) and enter your e-mail address.

You will then receive an e-mail containing a special URL. This URL will allow you to register for AgEcon Search, including choosing a password. The administrators of AgEcon Search will be notified of your registration and will assign you rights to submit papers to the AAEA 2008 section. We will notify you when you are ready to submit.

When this occurs, choose "Submit Your Paper" from the side box of AgEcon Search (<http://ageconsearch.umn.edu>).

- Choose American Agricultural Economics Association - 2008 from the list
- In the author /e-mail box, enter the e-mail for the person submitting the paper
- In the series box, enter: Selected Paper (no.) – i.e., Selected Paper 117877

- Fill in all other fields, using 2008 in the date field.
- The submission form will then prompt you to upload the PDF file from your computer and verify your submission.
