#### **Case Study Competition**

For the last eight years the AAEA Graduate Student Case Study Competition has provided graduate students with an opportunity to test their communication skills as well as their ability to apply knowledge of agricultural economics and agribusiness issues to a real-world agribusiness-related situation. The case this year highlighted the dilemma faced by eMerge Interactive regarding its two separate divisions. The three teams that advanced to the finals were: University of Missouri, Oklahoma State University, and Purdue University. During the finals competition the three teams gave their presentations to a panel of judges, which included the CEO of eMerge Interactive, Dave Warren. The winners were announced later that night at the Industry Banquet, with the University of Missouri team members H. Dorr and M. Mullins receiving first place, Purdue University team members J. AcMoody, M. Gunderson, and W. Peake receiving second place, and Oklahoma State University team members S. Howry, B. Prado, and R. Pruitt receiving third place in the competition. The GSS and winning teams would like to thank the Agribusiness and Economics Management (AEM) section for providing the tickets to the Foundation Banquet for the Case Study Competition finalists. ### Guidelines for Writing a CV & Resume

The GSS dedicated an entirely new track session to "Guidelines for Writing a CV & Resume" at the Providence meetings. Over 50 graduate students attended the new session, truly indicating a direct interest in this area. The session was moderated by Jennifer Keeling-Bond, former GSS Secretary from UC-Davis. The featured speakers within the session included two academia representatives, Dr. C. Alexander of Purdue University and Dr. C. Anderson of the University of Rhode Island, one government representative, R. Shewmaker, and one private sector representative, Dr. M. Wade.

#### Interviewing and Becoming a Successful Professional

Over 20 conference attendees participated in this session, which included presentations by Dr. D. Bernardo (Washington State University), Dr. M. Bohman (ERS-USDA), and Dr. A. Hallam (Iowa State University). Because of the strong interest and the positive comments of the participants of this session the GSS is planning to enrich this session with a greater variety of topics for the 2006 annual meeting. ## Economics and Social Science Research in Food, Agriculture, Environment and Development

On September 22-23, 2005, Wageningen University hosted the second-annual European Ph.D. Workshop for economic and social science research in the areas of food, agriculture, environment, and development. The workshop was combined with the annual Mansholt Graduate School (MGS) Ph.D. day. The MGS administration and its Ph.D. council took a leading role. The European Association of Agricultural Economics (EAAE) was also a major sponsor of the event. During this event Ph.D. students had the opportunity to present their research and receive comments from their colleagues, professors, and other experienced professionals. The call for papers attracted over 110 abstracts from Ph.D. students registered in 16 European countries. Fifty-nine Ph.D. students were selected to give oral presentations of their research in five workshops. The topics varied from consumer behavior and food safety to development aid. On the second day there was a one-hour session in which 20 posters were discussed. An invited group of top professors and researchers from the Netherlands, Belgium France, Germany, Italy, the UK, Norway, the US and Canada were present to provide feedback and comments.

Prof. A. Kuyvenhoven, MGS Director, delivered the keynote speech. In addition to the paper sessions and the poster session there were several plenary speakers, including Prof. S. Stefanou (Pennsylvania State University) and Dr. E. Romstad (Norwegian University of Life Sciences, President of the EAAE), among others. The plenary speakers discussed various topics, including guidelines and tips for publishing social research, and strategies for attaining quality standards and relevance in scientific research.
