### From the President

### To Atlanta, Denver, and Beyond...



While it has been only a few short months since our highly successful 2009 Annual Meeting in Milwaukee has concluded, we are busily making final preparations for the coming ASSA Annual Meeting in Atlanta that

is being held on January 3–5, 2010. And the intense planning efforts underlying the Centennial Meeting of the AAEA, held jointly with WAEA and CAES on July 25–27, are now rather rapidly converging to final form, and the content and experiences that will be part of the meeting celebrating the 100<sup>th</sup> anniversary of our venerable Association promises to be truly one for the ages!

For those of you who are planning to attend the ASSA Annual Meeting, I think you will be both pleased and proud about the excellent slate of high quality sessions that are being sponsored by the AAEA. I am confident that

our sessions will attract economists from a wide range of meeting attendees, and casting modesty aside, I am also optimistic that our offerings will be some of the most interesting and relevant sessions provided at the meeting this year. I hope to see many of you at the AAEA Reception at the Hilton on Sunday night, beginning at 6 p.m., followed by the T.W. Schultz Memorial Dinner, at which Dale Jorgenson of Harvard University will be providing the Keynote Address.

Regarding the 2010 AAEA, CAES, & WAEA Joint Annual Meeting in Denver, I respectfully recommend that this is one set of meetings you do not want to miss! I will discuss aspects of planned special meeting content, events, programs, and centennial themes in future editions of The Exchange, and you should have already received your first information update relating to the summer meetings in the every-other-month electronic newsletter that we are sending you called Denver on Demand. But given the approaching deadline for submission of Selected Presentation Abstracts (January 18), I wanted to specifically mention one important aspect of the Denver meetings that responds explicitly to feedback we received in our 2009 Annual Meeting survey, and that speaks to the opportunity for members to make a presentation at the coming summer meetings.

In particular, it is clear from survey results that the opportunity to present at the meeting

#### **AAEA Speaker Wins Nobel Prize in Economics**

Recently, the Nobel Prize Committee chose to award its 2009 prize in economics to Elinor Ostrom and Oliver E. Williamson. Ostrom was the Galbraith Forum speaker at the 2008 AAEA Annual Meeting. She is the latest in a long line of Nobel Laureates with ties to AAEA, including Vernon Smith, George Akerlof, Joseph Stiglitz, James Heckman, Daniel McFadden, Gary Becker, Theodore W. Schultz, and Kenneth Arrow.

Otto Doering, AAEA President at the time of Ostrom's speech, reflects on her award and her involvement with AAEA.

At the AAEA meetings in Orlando, I presented Elinor Ostrom with the association's Galbraith Award. I had known Elinor and her

husband Vincent since the late 1970s when applied economists beat a path to their door for their pioneering work on the provision of public services. Elinor won the Nobel Prize for her work on institutions for collective action that can prevent or mitigate the tragedy of the commons. Kevin Gallagher in *The Guardian* noted the thoroughness of her approach. In recent years this included resource depletion analysis by satellite observation, field and case studies, and then behavioral experiments to validate the other observations. In addition, Elinor has also been a prodigious idea generator. The gen-

#### Heading South Award Winner Focuses on Wind-Borne Diseases



Anton Bekkerman received the 2010 Heading South Award, which provides funding for him to attend the 2010 AARES Conference in Australia.

Anton Bekkerman, Assistant Professor at Montana State University, has been named the 2010 Heading South Award winner. As the winner of this award, Bekkerman receives funding to present his paper "Don't Compensate, Mitigate: Welfare Impacts of Check-Off Programs for Wind-Borne Diseases in the U.S."

at the 2010 Australian Agricultural and Resource Economics Society (AARES) Conference in Adelaide, Australia.

"I believe that the presented work on wind-borne invasive species can provide important perspectives and lead to future research in the field within the U.S. and Australia," Bekkerman said. "[Those] agricultural sectors have been subject to a number of destructive invasive species."

The Heading South Award is part of an exchange program between AAEA and AARES. Each year, both associations honor two young professionals who are members of both organizations, and give them the opportunity to take part in a new annual meeting. One resident of North America is invited to take part in the AARES Annual Meeting in Australia (the Heading South winner), and one resident of Australia or New Zealand is invited to present as part of the AAEA Annual Meeting (called the Heading North winner). Each winner receives funding for his/her trip, sponsored by both The AAEA Foundation and AARES.

#### Reach Out to Decision Makers!

Your work can have more impact on public and private sector decisions! The AAEA Outreach Committee's goal is to disseminate analysis and information to those outside the profession and to share Extension education materials among our peers to strengthen their education programs for policy and industry leaders. *Choices* and *Policy Issues* are our vehicles for the first, and the Shared Outreach Materials Library does the second.

The third quarter 2009 issue of Choices contains a very timely theme which addresses the national school meal programs due for renewal by Congress in the coming months. These programs are increasingly being challenged to provide more nutritional benefits to students, at the same time they face national and local budget pressures. Helen Jensen guest edits this insightful series of articles, drawing on her extensive research findings and experience in advising policy makers on these programs. The authors provide insights from the history and operation of the programs, identify the challenges facing them, and explore opportunities for innovative approaches through local and national initiatives. Lessons from behavioral economics and viewing the school food programs as a business at the school level may be extremely helpful to those delivering the programs to students.

An individual article by Bailey Norwood and Jayson Lusk analyzes the farm animal welfare debate, identifying issues that agriculture must come to grips with in order to be more effective in their arguments on behalf of the animal production community.

Another article by Martinez, Bingen, and Conner explores opportunities, barriers, and experiences of produce handlers in sourcing organic produce from the Great Lakes Region. The findings contain lessons for local sourcing of organic foods nationwide.

William Edwards, editor of the Shared Outreach Materials Library, encourages you to take advantage of the opportunity to contribute to a peer-reviewed set of materials, through this brand-new feature on the AAEA Web site. You may receive additional recognition by P&T committees for work you are doing to meet Extension program needs if it is peer-reviewed. # Call for Proposals Agriculture, Food, and Natural Resources Case Study Invited Paper Session

AAEA welcomes proposals for Case Studies for a special Invited Paper session that will be part of the 2010 AAEA, CAES, & WAEA Joint Annual Meeting in Denver. Cases in this Invited Paper session will be published in the *American Journal of Agricultural Economics* in January 2011. Regular page charges will apply. Proposals from individuals or groups must be submitted in electronic form to Lisa House (lahouse@ufl.edu) by January 18, 2010.

Proposals are requested for case studies that show how the application of economic principles to decision making in the public and private sectors leads to better decisions. All topic areas that show the application of economic principles are acceptable. Topic areas focusing on emerging issues such as: energy economics, food safety, and company environmental policies (e.g. green scorecard) are encouraged. Proposals will be evaluated by sufficiency in satisfying the following criteria:

- Deals with a problem that has a high level of importance/interest/relevancy to members of AAEA.
- Clear and concise teaching objective(s) and target audience(s) (e.g. undergraduate students, graduate students, extension audiences).
- Leads to a better understanding of how the application of economic principles leads to better decision making.
- A general description of the teaching plan for presenting the case to include expected student use of reference materials
- Case summary that presents solutions and explanations of how the learning objectives are realized.

Proposals should include case title, names and contact information of the authors, and a case outline that covers the company or situation profiled, as well as a detailed outline for the case study. The outline should be 3–5 pages in length and a maximum of 2,000 words. The proposal must also contain an outline and ideas for a teaching note, although the teaching note will not be published with the case.

Students also receive the opportunity to actively participate in the teaching and research missions of the university.
