Uma Lele Mentor Fellowship Award Call For Applications

The Agricultural & Applied Economics Association (AAEA) Trust is now accepting applications for the Uma Lele Mentor Fellowship Award. The Uma Lele Mentor Fellowship Award supports a mentorship relationship with a view to promote high quality research of a policy/problem solving nature in countries with food insecurity and environmental pressures. It is meant to promote collaboration between an early career scholar who is a citizen of and resides in a developing country and a distinguished mentor.

The award is intended to cover the costs of travel and expenses for a scholar and mentor to work together on a specific research project in a high priority area for the scholar's country. The maximum fellowship grant will be \$5,000. Up to \$4,500 can be allocated for travel expenses for the scholar to visit the mentor's workplace and/or to meet with the mentor at a professional meeting. Up to \$1,500 can be allocated for mentor travel and other expenses during the fellowship period. Research topics should fall within the mission of the AAEA (www.aaea.org/about-aaea).

Scholars should be professional economists who are citizens of and reside in a developing country. A complete list of qualifying countries is available under the headings "Low-income economies" and "Lower-middle-income economies" at: http://data.worldbank.org/about/country-classifications/country-and-lending-groups#Low_income. Scholars should either have completed their terminal degree or will complete it within the year. Students studying in countries that are not considered "low-income economies" and "lower-middle-income economies" may apply, but they must be completing their degree and planning to permanently reside in a "low-income" and "lower-middle-income" country by the end of 2021. Mentors can reside in any part of the world, but each must be an AAEA member.

Obituary

Fred Justus 1930-2020

Fred Justus, husband of Evelyn W. Justus for almost 68 years and Professor Emeritus of Agricultural Economics at the University of Kentucky, passed away peacefully at his home on July 24, 2020. He was born in St. Louis, MO, on June 30, 1930 to Fred and Emma Justus.

As a young boy, the family moved to a farm near Mascoutah, IL where Fred grew up. Fred graduated and received all of his degrees from the University of IL, and then served two years in the US Army at Ft. Lee, VA. Prior to coming to KY in 1967, he was Professor of Agricultural Economics at the University of MO. His duties as a professor at UK involved teaching, research and extension in Farm Business Management and Rural Real Estate Appraisal. He served as Coordinator of the KY Farm Business Management Program. The Southern Agricultural Economic Association presented him with a Lifetime Achievement Award. He was a long-time member of the American Society of Farm Managers and Rural Appraisers and a past College VP. He also served 20 years as Sec-Treasurer of the KY chapter of ASFMRA and served one year as its President. Fred was also recognized with a Sierra Club award for his work and dedication toward saving the Red River Gorge.

Fred was a devoted Boy Scout Leader for 50 years, serving as a Scoutmaster, Council Commissioner, and Council Boy Scout Leader Training Chairman. Mr. J, as he was known by his scouts, influenced and mentored many young men over the years and was known as a "one of a kind leader". He was a long-time member of the Executive Board of the Bluegrass Council, BSA. He was presented the Lamb Award by the Lutheran Church and BSA for distinguished service to youths. As a long time Lutheran, Fred was a member and attended services at St. John's Lutheran and Gethsemane Lutheran Churches. He served in various roles with both congregations, and had a strong faith that sustained him throughout his life.Fred lived a wonderful and full life.

He was a great husband to Evelyn, loving parent to all of his children, their spouses, grandchildren, and great grandchildren. Fred and Evelyn filled their lives with traveling, including all 50 states and Canada in their travel trailer. He especially loved Alaska (and had hoped to make one last trip), and Iceland on a recent trip. His other hobbies and vices included fishing, hiking, gardening, following Evelyn's directions, smoking his pipe, and his nightly bourbon happy hour. He was preceded in death by his parents, sister, Doris, and a brother, George.

Survivors in addition to his wife are his "4 good kids": David (Susan) of Bowling Green, KY, Linda (Don) Harkins of Overland Park, KS, Cathy Cook of Lexington, and Steve Justus (Jill) of Lexington. He has 11 grandchildren: Jason (Evelyn), Nathan (Tiffany) Ben (Aubrey) Harkins; Greg (Cassie) Justus; Quentin, Chelsea, Olivia Cook; Steven (Dolapo), Celena Justus; Kristi (Brian) Bledsoe; Heather (Mike) Hugo. Food Distribution Research Society Annual Conference 2020 Call for Research Reports, Updates and Outreach Writing

Deadline extended to August 31, 2020

The Food Distribution Research Society invites submissions of Research Reports, Research Updates, and Outreach Writing for the 2020 Annual Conference. Work related to any food distribution area from the farm gate through retail to the consumer may be submitted.

Due to the COVID-19 pandemic, the annual meeting will be conducted virtually via Zoom. Concurrent sessions will be held on Tuesday October 13th, 2020. We will meet in Dallas, TX in 2021.

Research Reports are scholarly papers focusing on the results of research efforts. Reports will be evaluated and accepted based on one-page abstracts that describe the research and its relevance to food distribution issues. *Presentations of research reports are limited to 12 minutes each, with 3 minutes for Q&A.*

<u>Research Updates</u> are synopses of research or educational work either (1) recently completed, (2) in progress, or (3) to be undertaken within the next year. To give an update, submit a maximum one-page description of the update. <u>Presentations of updates will be limited to 8 minutes each, with 3 minutes for Q&A.</u>

<u>Outreach Writing</u> is a relatively new category for the conference. We seek to recognize the types of technical communication of food industry issues that are key to the Extension/Industry Outreach work done by FDRS founders and that are central to many members' work today. Some refer to these articles as "industry outlook" or they may comprise content that may be contributed to publications such as *Choices*, i.e., content that communicate food supply chain and marketing issues to a non-academic audience. Submissions will consist of the actual article and the submission form. *Authors will have 8 minutes to present a summary of the article's key points and how it was used in outreach/Extension efforts.*
