#### Post-conference Workshop – Deadline Extended AAEA: Early Career Professional Mentoring Workshop

The AAEA Early Career Professional Mentoring workshop is aimed at professionals in research positions in applied economics in academic and nonacademic careers. The workshop will consist of a one and a half day program, beginning directly after the 2019 AAEA meetings in Atlanta, GA starting on July 24 and ending by mid-day on July 25, 2019.

The workshop will provide mentoring on topics critical for professional success in research and teaching careers. These topics include effective strategies for management of research activity, including obtaining funding, timely completion of projects and publications; communicating in the classroom and with external stakeholders; networking; and managing time and achieving work–life balance. The workshop will offer opportunities for mentees to interact in small groups with mentors in their research area of interest and obtain specific feedback on a completed draft of a research paper as well as more general guidance on strategies for success in their career path.

Potential mentees interested in applying to participate in this workshop should provide a 250 word description of their motivations for participating, desired learning outcomes, and list two broad research areas that describe the working paper they intend to submit for feedback at this workshop. Examples of research areas include International Trade and Development/Production Agriculture, Prices, Finance, and Farm AAEA 2019 ANNUAL MEETING ANNUAL MEETING ATLANTA JULY 21-23, 2019

Management/ Agribusiness/Environment and Natural Resources/Consumer Choice and Behavioral Economics/Applied Research Methods/Community and Regional Economics/Other.

Applicants with less than five years in their first professional position will be preferred. Attendees must arrange their own travel and lodging and pay a fee of \$85.

These grants defray housing and transportation costs associated with attending the 2019 AAEA Annual Meeting in Atlanta on July 21–23. The amount of the travel grant awarded will depend on the number of applications received. AAEA Trust Travel Grants (if awarded) are generally not large enough to offset all travel and lodging costs, nor more than half of international travel costs.

#### **Eligibility Requirements**

Qualifying applicants must meet the following eligibility requirements in order to be considered for a travel grant:

- Graduate student or Early Career Professional 2019 member of AAEA.
- Actively engaged in agricultural or applied economics fields, such as agribusiness, agricultural, consumer, food, development, environmental, health, marketing, regional, rural, or resource economics.
- Insufficient institutional funding available to make the trip (including from university, department, grant, employer, etc.)
- Paper/poster accepted for presentation at the 2019 Annual Meeting.

#### Announcing The 2019 Extension Competition for Graduate Students AAEA Atlanta, GA July 21–23, 2019

The AAEA Extension Competition for Graduate Students provides incentives and opportunity to develop extension and outreach programs from their research for an extension (usually noneconomist) audience. Entries can be based upon the graduate student's research for a thesis, dissertation or other academic work. The competition is sponsored jointly by the Extension and Graduate Student Sections.

#### Who's Eligible?

- Graduate students currently engaged in topics related to agricultural economics, agribusiness, natural resources, and community resource economics.
- Those who graduated from such programs in 2018 or later.
- Participants must identify and work with a mentor with experience in outreach or extension activities.

#### **Competition Application Information**

Applications should be addressed to Kate Fuller at <u>kate.fuller@montana.edu</u> and must include:

- **1.** Student's name, university, department, address and contact information.
- 2. Title of the extension program to be delivered.
- 3. A summary of the proposed extension program. This should include target audience, delivery plans, communication methods and activities planned for distributing the information to the public such as fact sheets, press releases, reports, web sites, spreadsheets, presentations and training activities (4 page maximum). If the applicant was part of a team, the role of the applicant within the team must be made clear.
- **4.** A profile of the applicant's background and research (1 page maximum).
- 5. The mentor's name, address and description of the mentor's role in assisting the student with this project.

#### Submission Deadline

Applications must be submitted electronically no later than **midnight MST on May 31, 2019**.

#### Finalists at AAEA

Finalists will be selected to make a 15-minute extension/outreach presentation at the AAEA meeting in Atlanta, GA on Sunday July 21, 2019, to a panel of judges, who will then ask 5 minutes of questions. The competition will begin at 8AM. Selection of the finalists will be based on the material submitted and the criteria listed below. Finalists will be notified by June 15, 2019. The top three finalists are be expected to make presentations during an AAEA Extension track organized symposium.

#### Criteria for Selecting Finalists

Criteria for judging finalists and winners will include:

- 1. Identification of a target audience.
  - a. An explanation of the issue/problem/opportunity being addressed.
  - b. An explanation on how this target audience was identified.
- 2. Development of an extension program for the target audience that includes:
  - a. An outline of the goals of the extension program, and a description of how the results will address the issue/problem/opportunity and benefit the target audience.
  - b. A summary and explanation of the main elements of the research results to be included in the extension program.
  - c. A summary or explanation of the program in an extension report, or extension presentation, or other appropriate extension communication media.
- An explanation of extension team development and responsibilities in terms of program development and delivery should be addressed, if appropriate.
- 4. Plans for evaluating the effectiveness of the extension program.

#### Awards

Cash awards will be given to those judged to be the top three graduate students in this competition. Award funding is provided by the AAEA Extension Section through membership dues and via support provided by sponsors. Awards are:

- First Place: \$1,000 and a plaque
- Second Place: \$300 and a certificate
- Third Place: \$200 and a certificate

Other finalists receive finalist certificates

The top 3 competitors selected will be recognized at the AAEA Awards ceremony. All finalists will be provided tickets to the Extension Luncheon during the AAEA annual meeting. #### **Post-Conference Workshop on Environmental Regulation and Innovation in Local Communities** 2019 NAREA Meeting & Workshop

The 2019 Northeast Agricultural and Resource Economics Association (NAREA) Post-Conference Workshop will be held June 11-12, 2019, in Portsmouth, NH. **Deadline is February 18, 2019.** 

Due to the need to remain globally competitive while espousing more sustainable production and consumption patterns, local communities are under increasing pressure to adopt innovative strategies to manage the economic and environmental impacts of environmental regulations. Further, increasingly decentralized regulatory design and enforcement can create wide disparities in economic and environmental outcomes across jurisdictions, reinforcing any anxiety and competition between states and local governments with respect to economic growth and environmental quality. Local communities can adopt productivity–enhancing and pollution reducing technologies while also developing innovative policy approaches and governance structures to manage these impacts. It is therefore imperative to understand how local communities innovate – both in the technological and policy/governance spheres, the factors that motivate them to do so, and how their innovations determine the environmental and economic outcomes they experience. Additionally, and equally vital is an understanding of how individual households and businesses in local communities help shape local environmental regulations and the channels through which they can influence the design of local regulations.

This workshop seeks to invite a conversation among researchers, think-tanks, government agencies and policymakers to enhance our understanding of how local communities innovate when shaping and responding to environmental regulations, and how these environmental regulations affect rural communities' economic well-being and environmental quality. Keynote speakers include: Kathleen Segerson, University of Connecticut; and David Popp, Syracuse University.

We are interested in soliciting empirical and/or theoretical papers using state-of-the-art methods to examine the impact of regulation on various metrics of innovation, environmental guality, and economic performance to assess the well-being of local communities - rural or urban - in the context of environmental regulation. We would like to invite papers that deal with a variety of innovative approaches to respond to regulation such as (but not limited to) abatement technology adoption and diffusion, environmental patenting, energy and transportation infrastructure, as well as innovative policy and governance approaches including information disclosure mechanisms, environmental management systems, social responsibility-oriented practices, government-NGO partnerships and other multi-stakeholder cooperative initiatives. We hope to see papers thinking about how regulation and innovation impact various environmental quality measures such as (but not limited to) industrial air, water, hazardous waste and other types pollution as well as issues related to land use, forest stewardship and management, and energy use. Further, papers that are related to regulation and innovation to economic performance, in terms of output and productivity, production efficiency, employment, investment, property prices, capital expenditures, infrastructure spending and global competitiveness, among many others. Finally, we are interested in attracting papers that examine how to enhance public participation of citizens in local communities and those that investigate the channels through which individual households and businesses can influence public policy.
