# President's Column

# January 2024

The AAEA Board recently met with the leadership of the Association of Environmental and Resource Economists (AERE) (Karen Fisher–Vanden, AERE President, Valerie Mueller, AERE board member, and Tonya Wade, AERE Executive Director). The primary focus of our meeting revolved around revitalizing the relationship between AAEA and AERE. One tangible idea that emerged from the discussions was a joint venture for a fall 2024 virtual workshop. This collaboration would involve selecting a mutual topic of interest and allowing members from both associations to participate as presenters and attendees. We are currently setting up a small working group to move this idea forward.



AAEA is continuing its efforts in Washington, DC to support federal funding for economic research and has been working with Congress and coalition partners to promote investments in key agencies and programs including the Economic Research Service, National Agricultural Statistics Service and the National Institute of Food and Agriculture. AAEA is also engaging with policy makers on the pending reauthorization of the Farm Bill and has advanced a petition to the Department of Homeland Security (DHS) requesting the addition of agricultural economics as a STEM designated degree program. The petition is currently under consideration by DHS. The next update to the STEM degree list is expected later this year. As I mentioned a few months ago, AAEA has a cooperative agreement with ERS to set forth a comprehensive strategy to enhance diversity and inclusion within the field of agricultural and applied economics. A goal is to expand the number of students from underrepresented groups pursuing advanced degrees and careers in agricultural and applied economics. We will further work to ensure students have the support, resources, and skills to complete degrees and successfully pursue research careers in agriculture and applied economics. The first year of the project is focused on the development of a formal plan generally described as follows:

- Short run: Develop a plan for identifying mentors and programs to support underrepresented minorities in the profession.
- Medium run: Increase the share of underrepresented groups in graduate programs and among early career professionals.
- Long run: Ensure long-term retention and success for underrepresented minorities through all stages of developing agricultural and applied economics professionals.

The working committee, chaired by Andrew Muhammad, has identified key focus areas for 2024, including strengthening partnerships with MANRRS and FFA, conducting a thorough census of initiatives across universities, and developing strategies to engage regional agricultural economic associations. Subcommittees will be led by committee members: Andrew Muhammad, Norbert Wilson, Cesar L. Escalante, Mohammed Ibrahim, Kenrett Y. Jefferson–Moore, Kristin Kiesel, Joey E. Mehlhorn, and Marco A. Palma. The committee will also be recruiting undergraduate and graduate students this year and hire a consultant to assist with project goals.

The AAEA Access Taskforce, established in August 2023, aims to identify concerns that limit all members of the AAEA from fully participating in the professional association, including the summer meetings. Members of this taskforce were recruited to represent several sections in the organization, including COSBAE, CWAE, Department Chairs Section (CHAIRS), Graduate Students (GSS), and Seniors in the Profession. The taskforce members are Sathya Gopalakrishnan (chair), April Athnos, Vincenzina Caputo, Gail Cramer, Elizabeth Fraysse, Chrystol Thomas, and Sarah Low. In the first three months, they have focused on (i) identifying key groups to connect with to understand challenges, needs, and potential opportunities; (ii) developing a process to seek input from AAEA members; and (iii) organizing focus group discussions to gather information from members to inform a member survey (Spring 2024). They have identified the following groups of AAEA members (and non–members) to connect with for input:

- Members in non-R1 universities (i.e., HBCU/1890/1994)
- Industry professionals
- Government professionals
- Graduate Students
- Caregivers and people facing career interruptions
- International members/scholars

They have also developed a short questionnaire and a series of open-ended questions for discussion to seek input from members. They plan to conduct more focus group discussions in Spring 2024, which will be followed by a member survey, with the focus group results informing survey content.

The AAEA Health and Wellbeing Task Force (Carola Grebitus and Alicia Rosburg (co-chairs), Kelly Davidson, Elena Krasovskaia, Bailey Samper, Anne Byrne, Jane Kolodinsky, John Lai, Nilufer Cetik, and Helen Jensen) is actively curating events for the 2024 AAEA Annual Meeting. They are in the process of developing a symposium focused on promoting health and wellbeing of AAEA members. Additionally, the task force is investigating various interactive conference activities designed to equip members with practical strategies for stress reduction and relaxation techniques.

# Call for submissions: AAEA invited paper sessions at the 2025 ASSA Annual Meeting

President–Elect Tim Beatty is soliciting proposals and suggestions for AAEA invited paper sessions at the 2025 Allied Social Sciences Association (ASSA) Annual Meeting in San Francisco, CA, January 3–5, 2025. The objective of AAEA sessions at the ASSA Annual Meeting is to share new knowledge of interest to economists. The AAEA encourages sessions that will draw widely from ASSA attendees, including sessions jointly sponsored with other ASSA member associations.

A subcommittee of the AAEA Board will review all proposals. Preference will be given to proposals that

- 1) Cover issues of national and international importance,
- 2) Expand capabilities and tools for economic research,
- 3) Promise a high-quality collection of papers suitable for publication.

Papers in approved Invited Paper sessions are eligible to be peer reviewed for publication in the proceedings issue of the *Applied Economic Perspectives and Policies*. Authors will be contacted by the *AEPP* editors with manuscript submission details.

Proposed formats for the 2-hour sessions may include either three papers with one discussant or else four papers with no discussant. All proposals must include a plan for fostering participant interaction.

Proposals should include the session title and paper titles, as well as the names, addresses, phone numbers, and e-mail addresses of the session organizer, moderator, paper presenters, and discussants. Proposal text should begin with a short justification of the session, followed by one paragraph abstracts describing the objective and contributions of each paper. The organizer is responsible for ensuring that all individuals identified in the proposal are willing to participate.

All speakers and discussants must be members of AAEA, although the proposal may request a membership waiver under special circumstances. Participants must register for the ASSA meeting.

# International Workshop on Survey Design and Experimental Methods in Applied and Agricultural Economics

Michigan State University- May 20 to May 24, 2024 - Exciting updates

Announcing the early-bird registration for the International Workshop on "Survey Design and Experimental Methods in Applied and Agricultural Economics" has been extended until March 15, 2024. Seats are limited, and registration is based on a first come, first served basis.

We are also excited to share some relevant updates, which will benefit substantially all participants. Here are some highlights:

- 1. Thanks to a generous conference grant from the USDA-NIFA-AFRI (markets and trade), we will provide every participant with 5 nights of lodging at a hotel near the workshop location. More specific information about the hotel will be made available soon in our workshop webpage, under "travel and accommodation" (please see the link), so stay tuned!
- 2. In addition, there are several scholarships available to cover travel/lodging expenses and participation fees, all with a submission deadline of February 1, 2024. The scholarships are offered by:
  - The AAEA <u>Trust</u>, which is providing \$10,000 for scholarships. Up to 20 students will receive scholarships in the amount of \$500 each.
  - The AAEA Experimental Economics Section (<u>EXECON</u>), which is providing \$1,000 for one scholarship to cover travel/lodging expenses.
  - The AAEA Institutional and Behavioral Economics Section (IBES), which is providing \$500 for one scholarship to cover travel/lodging expenses.
  - The International Workshop on Survey Design & Experimental Methods in Applied and Agricultural Economics, which is providing two scholarships of \$1,950 each to cover the participation fee for one student from non-R1 universities, including those from 1980 schools, and one student from an international institution.

Please note that the IBES, EXECON, and TRUST scholarships will be transferred directly to the awarded participants after the completion of the workshop by the respective donors. We will send you detailed instructions once the scholarships have been assigned. For the International Workshop Scholarship, we will

provide a registration code to the awarded participants after assigning each scholarship. This code will be used to waive the registration fee when registering for the workshop. For more information regarding the scholarships, please click here.

As a general reminder, the Workshop takes place from May 20 to May 24, 2024, at the Department of Agricultural, Food, and Resources Economics at Michigan State University. It covers theoretical and practical knowledge regarding surveys and experimental methods. In addition, delegates will be familiarized with state-of-the-art software, and will design their own practice experiment through hands-on training.

The Workshop is open to academics (students, professors, individuals employed by colleges and universities, and other institutions of higher education) and non-academics (consultants and other practitioners from the private sector or national and international organizations). # Call for Applications for Editor for Applied Economics Teaching Resources

The AAEA Board is seeking applications for a co-editor of Applied Economics Teaching Resources (AETR). The co-editor will further the journal's strategic goals, manage publications, enhance teaching and Extension education scholarship opportunities in the profession, promote innovations in teaching and Extension education methods, and expand the AETR Online Teaching Database.

Applied Economics Teaching Resources (AETR) is an online, open access, and peer-reviewed journal (<a href="https://www.aaea.org/publications/applied-economics-teaching-resources">https://www.aaea.org/publications/applied-economics-teaching-resources</a>). The aim of the journal is to provide an inclusive outlet for research, teaching and Extension education scholarship encompassing but not limited to research articles, case studies, classroom games, commentaries, experiential learning, and pedagogy. The goal is to support and advance teaching and Extension education within the scholarly areas of agricultural and applied economics, and agribusiness economics and management. AETR seeks to publish articles that are diverse in both scope and authorship. It serves as a platform for addressing and contributing to our understanding of important societal issues, including inequality and discrimination, as well as how shifts in pedagogy (e.g., growing reliance on remote and hybrid learning modalities) may impact accessibility and inclusion.

Applications: Applications for the co-editor position should include a narrative describing how the applicant will further promote the journal; enhance teaching and Extension education scholarship and methods; promote and expand the use of the AETR Online Teaching Database; and the unique qualifications the applicant brings to the position. Additionally, applications should include a cover letter and current CV, as well as provide a statement of support from their host institution. AAEA will provide a small honorarium and financial assistance for AETR-related travel.

Responsibilities: AETR editors are responsible for the development, coordination and publication of all content in the journal, including regular submissions, special issues, thematic sections and feature articles. In addition, the editors oversee distribution of teaching notes and supplemental materials, as well as development, management, and oversite of the AETR Online Teaching Database. The editors provide leadership, coordination, and oversight of all aspects of publishing in conjunction with the AETR Editorial Board and AAEA Business Office. Once a new editor is selected, the co-editors will divide the editorial responsibilities as appropriate. The expected starting date for the co-editor is July 2024 with on-boarding beginning in Spring 2024.

# Call for Applications Editorship of the Applied Economics Perspectives and Policy

The AAEA Executive Board invites applications for one editor for *Applied Economics Perspectives and Policy (AEPP)* to serve from 2024 through 2026. This call for applications is for an editor to manage Submitted Articles which contain original research results addressing real-world problems with sound research

approaches and/or have strong policy relevance within the subject matter of the journal. The degree to which candidate's expertise complements that of the continuing editors, will be considered in the selection process. The AAEA is particularly interested in candidates who will bring ideas and innovations for helping *AEPP* to further its mission.

Submitted articles will meet the normal standards for scholarly publication, but should also be accessible to the broader audience of agricultural and applied economists working outside academia. Submitted articles should emphasize one or more of the following: a) practical implications for public policy; b) clarification of research implications so as to maximize accessibility and cross-fertilization across specific areas of research; c) empirical comparison of competing theories, explanations, and approaches that can refine future research; and d) development of fruitful directions for future research. The editor will work with an editorial team comprised of two other Submitted Articles Editors, and a Managing Editor to manage the manuscript review process. The Submitted Articles Editors are responsible for day-to-day issues relating to submitted articles, assisting with development of the Special Issues, and revising editorial policy. The *AEPP* editorial process employs electronic submission of manuscripts and interchange between editors and reviewers. An electronic system that tracks manuscripts through submission, review, and editorial decision is used by the editors for managing work flow. Authors can also query this system for e-mail reports on the status in the editorial process of a submitted manuscript. The editors also oversee the work of Wiley in preparing copy for printing and reviewing proofs.

The new editor should be prepared to begin on June 1, 2024. There may be some training and coordination work starting prior to June 1<sup>st</sup>. Applications should include a statement of editorial philosophy and ideas for furthering the journal's goals, an indication of the candidate's principal areas of expertise to support the *AEPP*'s mission, a curriculum vitae, and a statement of administrative and financial support to be provided by the host institution. AAEA will provide financial assistance to defray some portion of the editor's time and most expenses. # Announcing a new AAEA Special Purpose Fund: Boehlje Agribusiness Management Fellowship

The purpose of this Fellowship is to provide financial support for graduate students with an interest in agribusiness management to continue their education through the PhD in preparation for an academic career in these areas.

**Background**: After graduating from Iowa State University in AgEcon, Mike Boehlje received a NDEA Fellowship to attend graduate school in Agricultural Economics at Purdue University where he received MS and PhD degrees. The NDEA Fellowship was critical to enabling him to pursue graduate work which then led to academic career faculty and administrative positions at Oklahoma State, Iowa State, University of Minnesota and Purdue. The focus of his academic work was managerial economics and farm/agribusiness finance and management. He was an active member of AAEA and recognized as an AAEA Fellow.

The goal of the Fellowship is to support the education of graduate students for faculty positions in Departments of Agricultural Economics in the critical area of agribusiness management.

A Fellowship of \$3,000 would be offered annually. Applicants would be expected to provide their plan of study and a brief description of their research interests and/or project.

# Special Issue: Artificial Intelligence and Data Analytics Use in the Classroom and Academy

Applied Economics and Teaching Resources is calling for manuscripts about use of artificial intelligence (AI) and data analytics in undergraduate and graduate education in the classroom and across the academy. Submissions of case studies, teaching and extension scholarship and research, educational innovations and methods, extension education innovations and methods, and commentaries about use of artificial intelligence, including use of large language models (LLMs) and platforms, such as ChatGPT, Bing AI, Bard, amongst other, and data analytics in undergraduate and graduate education, extension education, and other learning venues in institutions of higher learning. This special issue is open to a wide array of topics related to artificial intelligence and data analytics across the agricultural and applied economics and agribusiness and management economics disciplines. Topics may include but are not limited to innovative use of AI and data analytics in the classroom; innovative data analytic teaching modules and teaching case studies; teaching case studies about the impact of AI on agriculture, the agricultural industry and society; ethical and academic concerning the use of AI in the academy; assessments of AI for different learning outcomes and tasks; and use of AI and data analytics in extension education programming.

If you are interested in making a submission to the special issue, please submit a 300 word abstract to Dr. Jason Bergtold (<u>bergtold@ksu.edu</u>) by **June 30, 2024**, at the latest. The abstract should describe the overall theme/topic of the manuscript, how it relates to the special issue call, and how it can be used for educational purposes. Your abstract will be reviewed once submitted and you will then be informed if you will be invited to submit a submission to the special issue.

Full papers for accepted abstracts must be submitted through AETR at <a href="www.aetrjournal.org">www.aetrjournal.org</a>. All papers will go through a double-blind peer review process and be available online via Advanced Access for readers once accepted. # Research Innovation and Development Grants in Economics Program (RIDGE)

The RIDGE Program encourages new and innovative research on food and nutrition assistance issues and broadens the participation of social science scholars in such research. RIDGE is funded by USDA, ERS and USDA, Food and Nutrition Service (FNS) and is administered in partnership with public or private institutions of higher education.

# Request for Proposals (RFP) for RIDGE Grants

The USDA, ERS and RIDGE Partnership are pleased to invite proposals for new research, as part of the RIDGE Partnership 2024 grant cycle. Proposals are due **January 31, 2024**. # **RIDGE Partnership Award**

The new RIDGE partnership was awarded to Tufts University, the University of Connecticut (UConn), and the University of Missouri on September 16, 2022. Funding for a second round of research grants was provided to the RIDGE Partnership in 2023, to be awarded in 2024.

## 2023 Grant Awards

The 2023 round funded eight research grants to enhance food security and dietary quality in Federal nutrition assistance programs in 2023. Using a wide variety of data sources—including surveys, administrative data, and qualitative methods—these research projects informed the public on programs that provided nutrition assistance to people of all ages across the United States. The previous RIDGE program issued a request for proposals in December 2022. Applicants submitted short concept letters on food and nutrition assistance issues in which applicants would like to conduct research. The selected applicants were invited to submit full proposals. All full proposals were reviewed by external reviewers, USDA reviewers, and by the program directors at the University of Connecticut, Tufts University, and the University of Missouri. Using recommendations from the RIDGE partnership, the award decision was made by USDA, ERS and USDA, FNS and announced in March 2023.

The <u>Tufts/UConn/University</u> of <u>Missouri RIDGE partnership</u> oversaw the application, peer review, award, and performance processes of the research grants provided through the RIDGE Program. The Tufts/UConn/University of Missouri partnership served as a hub for mentoring and training researchers interested in food and nutrition assistance issues and provided a source of timely and accessible information on research findings. The Tufts/UConn/University of Missouri partnership sought applicants from a diverse community of experienced nutrition assistance researchers, graduate students, early career scholars, and established researchers who brought expertise in another research area.

# Conferences

USDA, ERS and its partner institutions host the Food and Nutrition Assistance RIDGE Program Conference, at which RIDGE researchers present findings of completed projects. The last RIDGE Conference was held on October 14, 2020. For information about this most recent conference, see the <u>2020 Research Innovation and Development Grants in Economics Program (RIDGE) Conference</u>.

The next RIDGE conference will be held in the Fall of 2024. Details about this 2024 conference will be announced here when they are available.

# **Research Project Summaries**

RIDGE, known as the Small Grants Program until 2006, has funded more than 280 completed projects at more than 100 educational and research institutions from 1998 to 2019.

Previous RIDGE partners include: Tufts University/University of Connecticut (UConn); the Institute for Research on Poverty (IRP), University of Wisconsin-Madison; the Center for Regional Development, Purdue University; the Southern Rural Development Center, Mississippi State University; the American Indian Studies Program, University of Arizona; the Harris School of Public Policy, University of Chicago; the Joint Center for Poverty Research, University of Chicago and Northwestern University; and the Department of Nutrition, University of California, Davis.

Posters will be displayed the afternoon of July 24 and the morning of July 25. Students submitting posters will receive complimentary registration.

The Farm Financial Standards Council is dedicated to helping farmers by promoting uniform financial reporting and analysis in the ag industry. Its goal is to be the definitive resource for financial guidelines to benefit farmers.

In accordance with this mission, the Council is including Poster sessions for individuals interested in serving the agricultural industry in financial, management, or analytical roles. The Posters should address any issue that relates to:

- Increasing the adoption of uniform financial reporting and analysis;
- Improving the financial management of farms;
- Using financial records and analysis to improve marketing and trade of food, fiber, and energy production;
- Methods to improve education and training for people involved in the agricultural industry this could include analysis of training projects like "Annie's Project," increased farmer use of FFSC Guidelines, or innovative University Extension projects;

A printed program will list the poster titles, authors, and presentation times. After the meeting all of the presented poster abstracts will be posted online as part of the meeting summation.

# **Guidelines for Poster Abstracts**

Authors must submit an electronic version of their poster abstract only, preferably as an (Adobe) PDF document, but a Microsoft Word (\*.doc, docx document) is also acceptable. See submission guidance below.

- 1. Poster abstracts must be submitted by March 1, 2024.
- 2. The official language for the poster abstract is English.
- 3. A poster abstract should explain the purpose and conclusions of the contribution. It should include a brief overview of the research, the methods and principal results.
- 4. Poster abstracts should not exceed 300 words and should not contain photographs, figures, tables or references.
- 5. Members of the FFSC Poster Review Committee will review all poster abstracts and authors will be notified of acceptance by March 21, 2024.

# **Guidelines for Poster Display**

- 1. The official language for posters is English.
- 2. One display panel/easel will be provided for each accepted poster. Posters should not exceed the following dimensions: 3 feet (91 cm) wide and 4 feet (122 cm) high. Appropriate materials will be provided to mount posters to the display panel. Posters should be readable from a distance of 3 ft (0.9 m). For adequate visibility, letters should be at least 3/8 in (1 cm) high after enlargement to full poster size. Photographs should be a minimum of 8 x 10 in (20 x 25 cm); the minimum size for all other illustrations is 9 in x 12 in (23 x 30 cm).
- 3. Presenters should set up their poster by 4 p.m. on July 24th. Posters will be displayed in a common area and presenters will be given an opportunity for a dedicated Q&A session on the afternoon/evening of July 24th and at select times during the morning on July 25th. All presenters will be excused at noon on July 25th. However, they will be encouraged to stay for the remainder of the conference that day and on July 26th.
- 4. All posters must be removed by noon on July 25th. Students/posters will be released at that time so as to return home in a timely manner.

# Fees

- Presenters are responsible for all travel/lodging expenses. Student presenters will be provided with a complimentary registration to the FFSC Conference. This will include meals/sessions/distributed materials.
- Academics and industry professionals will be required to pay the 'member' registration fee for the meeting.
- Students, academics, and industry professionals will be required to pay for any ancillary programs held in conjunction with the conference (Friday agricultural tours, special off-site programs/meals.)

Measuring and Enhancing Resilience of United States Rural Communities in the Context of Climate Variability June 11 - 12, 2024 | Rehoboth Beach, Delaware

Organizers: Laura Paul (USDA ERS, <u>laura.paul@usda.gov</u>) and Jonathan Malacarne (University of Maine, <u>jonathan.malacarne@maine.edu</u>)

Theme: Resilience describes the ability of an individual or community to anticipate, absorb, and recover from a negative shock. This workshop is motivated by the need to better understand the implications of increasing climate variability for the resilience of communities in the United States, acknowledging that implications can be either direct, such as the impacts of negative shock events on individuals and communities where they occur, or indirect, such as impacts on communities connected or adjacent to those experiencing shocks.

This workshop will bring together policy makers and researchers analyzing climate adaptation and mitigation of consequences for rural communities in the United States. The workshop focuses on (1) defining and measuring resilience, (2) anticipating and identifying the direct and indirect impacts of climate variability, and (3) contributing evidence towards policies to improve resilience.

Workshop Activities: The objectives of this workshop are (1) to identify research priorities and opportunities related to rural resilience and (2) to disseminate research related to the resilience of rural communities. Activities include:

Networking opportunities to develop new collaborations across government and academic institutions Introductions to new and existing data products related to the measurement and implications of climate variability on rural communities in the US

Idea generation and constructive feedback on new and existing research projects

Round table discussions and keynote to disseminate the latest findings on measuring and enhancing rural resilience

Call for Submissions: We invite paper submissions that broadly address the following topics as they apply to rural communities in the United States (not an exhaustive list):

- Measuring resilience and adaptation in the context of climate variability
- Identifying community traits associated with vulnerability and resilience to natural hazards.
- Informing policy actions to improve resilience and adaptation
- Defining and measuring the economic impacts of climate risk and variability
- The above topics could be explored through the lens of (but not limited to): food security and access, environmental justice, managed retreat, broadband access, natural hazards preparedness, rural migration, and land use

Submissions must pertain to rural communities in the United States. All accepted draft manuscripts will be considered for a travel award to offset domestic travel costs to the NAREA Annual Meeting and Post Conference Workshop.
