President's Column

July 2018



AAEA presidents have a threeyear term, which maintains leadership continuity. Their roles evolve from planning in the President Elect year, to implementation in the President year, to follow-up and mentoring in the Past President year. The

Presidential year culminates with our August meeting. So what has happened this year? This column offers retrospect and prospect, focusing on the new *Applied Economics Teaching Resources* publication, government relations, mentoring, AAEA journal publisher, and budding initiatives.

Applied Economics Teaching Resources moves forward with Bergtold as Editor - Teaching and learning about agricultural and applied economics is central to our Association's mission. To better address that mission, the AAEA Board voted in January to create a new publication on <u>Applied</u> *Economics Teaching Resources (AETR)*. The Board just selected Jason Bergtold of Kansas State University as the inaugural Editor of the AETR. The AETR will be a new home for everything related to teaching applied economics. That embraces teaching resources from economic games to decision cases, as well as evaluation and idea exchange on effective teaching. Expect to hear more from Jason as he shapes this new AAEA publication and explores creative ways to measure the learning impact of the teaching resources published there.

Ensuring that AAEA is heard in Washington, D.C. -AAEA has started actively supporting our profession in the policy realm. It had long been AAEA policy that the Association "will take no policy positions." Many applied economists make policy recommendations, and we wish to avoid the appearance of conflict of interest. However, this policy stifled the AAEA from speaking out on behalf of member interests when peer associations were actively advocating for their own. In January 2018, the AAEA Board amended our Operating Policies to allow "expressions of support for research, education, and outreach related to agricultural and applied economics." This small change has allowed the AAEA to advocate for USDA economic research and for including agricultural and applied economists on USDA advisory boards. AAEA will not take any position on what economic policy should be. But we are pleased now to be able to advocate the value of what agricultural and applied economists have to contribute.

Mentoring – When I ran for AAEA President, I promised to expand mentoring opportunities for job market candidates at the winter ASSA and also to offer workshops to build communication skills. At the 2017 ASSA meetings, we created a mentoring match-up program that has connected well over a hundred job market candidates with established professionals over the past two years. This initiative supplements the informal mixing at the AAEA reception for Early Career Professionals at ASSA. On the communication front, I am very

excited about this summer's post-conference workshop on <u>Science Communication and Media</u> <u>Engagement</u>, which AAEA is conducting jointly with the American Association for the Advancement of Science (AAAS). When AAEA members do timely, important research, like the work featured in the <u>Choices</u> theme on the <u>US-China Trade Dispute and</u> <u>Potential Impacts to Agriculture</u>, our impact is magnified by reaching out to the media. The AAEA-AAAS workshop will show how.

AAEA journal publisher planning - AAEA journals have had a wonderful nine-year run with Oxford University Press. With our contract expiring in December 2020, the Association issued to academic publishers a request for proposals. The Executive Committee and representative editors from the *A*/*AE* and *AEPP* will interview the top three candidate publishers (including OUP) on July 26. During its August 3-4 meeting, the AAEA Board will select a publisher for the years 2021-25. Conveniently, the AJAE's newly released journal impact factor for 2016 leaped to 2.46 from 1.83, highlighting the impact of our research. By the way, to mark the AJAE centennial, the editors will host an organized symposium on how the journal and its content have evolved (August 7, 1:00-2:30pm, Coolidge Room, Washington Marriott Wardman Park).

Future initiatives – The AAEA Board will be looking into several future initiatives this summer:

- How to revitalize AAEA Employment Center at the summer meetings? With the migration of many academic job interviews to the winter ASSA meetings, AAEA has boosted support to job market candidates at that forum. We are looking to expand job offerings for MS graduates through a job fair. Got suggestions? Let us know!
- Exciting mentoring initiatives for early and mid-career researchers are set for Board approval.
- 3. To ensure good **professional conduct** and freedom from harassment at our meetings, the Board will consider a new policy proposal.
- 4. To facilitate **child care** access during AAEA meetings, the Board will consider a new proposal.

It has been an honor and a pleasure to serve as AAEA President this year. AAEA is an extraordinary community of passionate, thoughtful economic professionals. That community bubbles with good ideas, making our whole much greater than the sum of its parts. We are fortunate to rely on the leadership of Executive Director Kristen McGuire and the rest of AAEAs staff team. After August 7, I look forward to becoming Past President and to supporting implementation activities led by President David Zilberman and planning by President-Elect, Keith Coble.

Post-conference Workshop: Science Communications and Media Engagement

Workshop Description: AAEA has engaged the American Association for the Advancement of Science (AAAS) Center for Public Engagement with Science and Technology to conduct a communications workshop for our members. This four hour workshop will be divided into two parts. The first part, termed Science Communication Fundamentals, focuses on the core components of successful public engagement. Participants are introduced to the AAAS public engagement framework, a guide they can apply to all kinds of interactions. Participants also learn how to identify a public engagement goal, determine the relevant audience, craft tailored messages to achieve their goal and rehearse their engagement scenario. This workshop includes both facilitator presentations and attendee exercises. Examples include:

- learning why economics communication is valuable and how to engage in outreach activities
- understanding and connecting to public audiences
- selecting audiences and developing targeted engagement strategies
- identifying individual strategic communications goals
- handling interaction with stakeholder audiences
- accessing resources to communicate science and economics and find outreach opportunities

The second component termed, Strategic Media Engagement, provides agricultural economists an

understanding of established best practices with regard to media engagement. It includes:

- overview of the science media landscape
- strategies for effective targeting of messages
- handling interaction with media and public audiences

Brief Description of Topic: The purpose of this workshop is assess engagement and collaboration, and to explore strategies to enable collaborative linkages to address institutional, funding, and operational gaps between the 1890 and 1862 land grants, and other institutions in agricultural economics research, teaching, and extension. Obituary

Robert W. Taylor 1935-2018



Robert W. Taylor, 83, resident of Lafayette passed away Tuesday, July 3, 2018 at home. He was born February 5, 1935 and grew up in Lawtons, NY, on Dancote Farm raising Angus beef. Bob graduated from Cornell University in 1956. On June 2,

1956 he married Anna B. Cady in Troupsburg, NY. They relocated to West Lafayette, IN, where he completed his MS and Ph.D. in Agricultural Economics from Purdue University. Bob joined Purdue faculty as a Farm Management Professor in the Agricultural Economics Department. His passion and concern for students was legendary, and he continued teaching and mentoring for 50 years at Purdue.

Bob was not just recognized and admired by his students for his caring approach to challenging their thinking and stimulating them to learn, but also for his sincere interest in them as individuals with personal as well as professional aspirations. Through his dynamic classes and caring connections with students, he built relationships that lasted a lifetime. He also worked in extension, emphasizing family farm business arrangements. Bob was a member of Evangelical Covenant Church of Lafayette, Indiana where he taught Jr High Sunday School for many years. He left his mark on thousands of families across Indiana. Former students remember Dr. Taylor for his daily quizzes, expressive teaching style, and especially for his wonderful ability to listen. Grandchildren remember him for his enthusiastic stories and sneezes, his wholehearted encouragement in life and learning, and his raised eyebrows and the suspenders he wore.

Outside of teaching, Bob enjoyed spending time in his woodworking shop making grandfather clocks and gifts for his family. He loved spending summers at the family cottage in Western, NY, where he spent hours of fun driving the boat, pulling skiers, and attempting to knock kids off the tube!

Surviving with his wife are his children Bill of Brighton, CO; Cindy (Bill) Fate of Lafayette, IN; Susan (Michael) Barker of Laramie, WY; Dan (Audette) of Rossville, IN. He was blessed with grandchildren Clayton (Sam) Taylor and Stephen (Christy) Taylor of Columbus, OH; Kevin (Rayna) Barker, Denise Barker, Karen (Joe) Marr, and Daniel (Liberty) Barker of Wyoming; Jacob, David, Sarah, Katie, and Karie Taylor of Rossville, Indiana; and 6 great– grandchildren. Also surviving are his brothers David (Leena) Taylor of Broomfield, CO; Donald (Sally) Taylor of Ames, IA; and sister–in–law Sylvi Taylor of Gettysburg, PA.

Bob was preceded in death by his parents Clayton and Annie (Clark) Taylor and his brother Philip J. Taylor of Lawtons, NY.

Larry Jonathan Held 1949-2018

Dr. Larry J. Held, Professor Emeritus in the Department of Agricultural and Applied Economics at the University of Wyoming, and long-time member of both the AAEA and WAEA, passed away on June 28, 2018 after battling a long illness. Larry was born on September 19, 1949 in Devils Lake, North Dakota and grew up on his family farm near Rock Lake, North Dakota.

Larry's passion for production agriculture led him to pursue and obtain both his B.S. and M.S. in Agricultural Economics at North Dakota State University. Larry accepted an assistantship to pursue his doctoral work with Dr. Glenn Helmers at the University of Nebraska-Lincoln after receiving his M.S. in 1973.

Upon completion of his PhD in 1977, Dr. Held accepted a teaching and research position at the University of Wyoming in what was then the Department of Agricultural Economics. His position responsibilities focused on the area of Farm and Ranch Management. Dr. Held's research examined the economics of sustainable integrated livestock and cropping systems, precision farming, decision-making under risk and uncertainty, and factors affecting costs of production. His methods largely used enterprise budgets, simulation and mathematical programming, including some of the early works published in the literature utilizing MOTAD and target MOTAD. His research appeared in many of the regional agricultural economics journals, as well as in the *Journal of Production Agriculture*, the *Agronomy Journal, Journal of the American Society of Farm Managers and Rural Appraisers*, and was the subject of numerous extension and experiment station bulletins. Larry was known for his ability to conduct interdisciplinary research with agronomists, agricultural engineers, and weed scientists. He was the "go-to" person for many of the other production scientists in the UW College of Agriculture when designing and analyzing interdisciplinary research related to the economics of alternative cropping and weed management strategies.

During his career he taught Farm and Ranch Business Records, Farm and Ranch Management, Advanced Farm and Ranch Management, and Agricultural Finance. His teaching style and willingness to help students garnered him multiple teaching awards. He received both college and university level teaching awards, as well as the Western Agricultural Economics Association undergraduate teaching award and the USDA NASULGC Excellence in Land Grant College and University Teaching Award. Larry also received the Gamma Sigma Delta Award of Merit and is listed in Who's Who Among America's Teachers.

Larry provided a model for other faculty to emulate when it came to mentoring students. His open door policy and willingness to listen to students with a patient father-like quality garnered him the respect and devotion of countless graduate and undergraduate students during his 34-year tenure at UW. Year-after-year Larry delighted in communicating and meeting with past students, and many of his former students sought him out when they were in Laramie. It was common to find in his office a new card, letter or picture of a recent child from a past student. His connections created lasting memories for alumni, and produced loyalties amongst current and past students regarding Larry, the department, UW, and agricultural economics as a discipline. Farewell Dr. Held.

2018 FDRS Student Food Marketing Challenge Call for Participation

The 2018 Annual Meeting of the Food Distribution Research Society will be held at the Crystal Gateway Marriott, Arlington, Virginia, from September 14 – September 18, 2018. The conference will be held in conjunction with United States Department of Agriculture, Farm Credit, Farmers Market Coalition, and National Value–Added Conference under the umbrella of the "2018 Direct Agricultural Marketing Summit."

The Student Food Marketing Challenge Competition will be held on September 15. The competition will

provide students with the opportunity to play the role of consultants for an industry client, as they apply their knowledge

of food distribution, marketing, management, economics, and merchandising to a real world problem. Details about the client and case challenge will be disclosed to teams two weeks in advance of the competition.

Representatives from the company will give an overview of the challenge and conduct team interviews on the day of the competition. The first
