Call for Mentoring/Coaching Initiatives

The AAEA Mentorship Program Committee is now accepting proposals for mentoring and coaching initiatives.

A mentoring activity is defined as one where a senior member of the profession serves as an advisor on career decisions and challenges to a young or mid-career member of the profession. A coaching activity involves the development or improvement of specific skills; for example grant writing, new teaching methods, or engaging with industry in outreach activities.

The call is open to all AAEA members. The AAEA Mentorship Program Committee encourages collaboration across members, AAEA Sections, and also USDA regional groups to maximize participation and optimize the allocation of resources. AAEA expects to fund between 2 and 6 proposals in levels of \$5,000-\$10,000. The activities proposed and all expenses will need to be completed by the end of October 2019.

Selection criteria:

- 1. Clear description of the activity and justification of how it will benefit participants.
- 2. Number of beneficiaries
- 3. Structure of the programmed activity and quality of the speakers/mentors
- 4. Value for money

Proposal submissions should include:

- 1. A cover sheet with name of applicant; applicant's mailing address, email, and phone number; title of the project; abstract of the project; timing, duration, and location of the project; and amount of funding requested.
- A project description, not to exceed five double-spaced pages, including the purpose, scope, implementation procedures, the individuals responsible for management of the project, date/timing of the project, and location of the project.
- 3. An itemized budget, indicating costs to be borne by the grant and funding provided by other sources, if any.

Proposals should be submitted as a single PDF file to Sinais Alvarado at <u>salvarado@aaea.org</u> by **Friday, November 30, 2018**, to ensure consideration for funding for the next year. Proposals will be reviewed by the AAEA Mentorship Program Committee, which will make recommendations to the Executive Board for action at the January 2019 Board Meeting.

Call for Applications

Editorship of the American Journal of Agricultural Economics

Editorship appointments for the American Journal of Agricultural Economics are staggered such that two new appointments are made every two years. The AAEA Board now seeks applications for two editors to be appointed for a four-year term, beginning in January 2020. Each editor handles approximately one-fourth of the submitted manuscripts and makes independent editorial decisions on these submissions. The degree to which candidate's expertise complements that of the continuing editors, Tim Richards and Terry Hurley, will be considered in the selection process.

In addition, editors share the administrative responsibilities of managing the AJAE. Each editor should plan to dedicate 25 to 40 percent of his/her time to *AJAE* editorial duties. AAEA will provide financial assistance to defray some portion of the editors' time and most expenses.

Transition Timing

The AAEA Board will make final selections by early 2019. The new editors should be prepared to begin the transition process at the 2019 AAEA Annual Meeting in Atlanta, July 21–23, 2019 and expect to

be fully engaged in editorial duties by January 1, 2020. Interested candidates can consult the journal website for information on the journal at <u>www.ajae.oxfordjournals.org/</u>. Please note that all editors need to maintain their AAEA membership throughout their service to the journal.

- a brief statement expressing interest which should include applicant's areas of expertise and editorial philosophy for the AJAE,

- statements of administrative support from the candidate's department chair, dean or other appropriate administrative officer.

The Uma Lele Mentor Fellowship Award supports a mentorship relationship with a view to promote high quality research of a policy/problem solving nature in countries with food insecurity and environmental pressures. maximum fellowship grant will be \$5,000. Up to \$4,500 can be allocated for travel expenses for the scholar to visit the mentor's workplace and/or to meet with the mentor at a professional meeting. Up to \$1,500 can be allocated for mentor travel and other expenses during the fellowship period. Research topics should fall within the mission of the AAEA (www.aaea.org/about-aaea).

"The Opportunity Atlas: The Geography of Economic Opportunity in America"

Raj Chetty is the William A. Ackman Professor of Economics at Harvard University. He is also the Director of the Equality of Opportunity Project, which uses "big data" to understand how we can give children from disadvantaged backgrounds better chances of succeeding. Chetty's research combines empirical evidence and economic theory to help design more effective government policies. His work on topics ranging from tax policy and unemployment insurance to education and affordable housing has been widely cited in academia, media outlets, and Congressional testimony.

Chetty received his Ph.D. from Harvard University in 2003 and is one of the youngest tenured professors in Harvard's history. Before joining the faculty at Harvard, he was a professor at UC-Berkeley and Stanford



University. Chetty has received numerous awards for his research, including a MacArthur "Genius" Fellowship and the John Bates Clark medal, given to the economist under 40 whose work is judged to have made the most significant contribution to the field.

Abstract: This project will model linkages between biophysical processes and socio–economic factors and how these impact regional agricultural production and food consumption patterns that contribute to regional food security. The model will simulate the dynamic relationships and interactions between agricultural producer's decisions, food consumer's decisions, and the processes that influence land and water quality, and how these interact, resulting in areas with low food accessibility. The research will be conducted in geographically varied settings in North Carolina with changing demographic profiles. The project will be conducted by investigators at two Historically Black Colleges and Universities and will help develop scientific research capacity. The project will include research and educational experiences for underrepresented undergraduate as well as graduate students, and will also provide research training for a post–doctoral fellow, further building research capacity. The project will also include stakeholder (local and state planning agencies, extension agents, agricultural producers, and food retailers) engagement and contribute to facilitating the design, development, and delivery of policy–relevant information, specifically identifying policies that either support or hinder food security.

The existence of areas with low accessibility to healthy foods, often referred to as food deserts, have been identified as a serious issue contributing to food insecurity in both urban and rural areas in the U.S, especially in areas where minority populations reside. More integrated and interdisciplinary research is needed to examine and understand the multi-dimensional and complex problems that lead to this condition, and ways to mitigate it. The goal of this project is to better understand the factors that contribute to improving food accessibility, while maximizing agricultural production and minimizing negative environmental impacts on the land and water used in food production. Specifically, the objectives of the project are to (1) build an integrated modeling framework that includes natural system models (biophysical model, GIS land use model), human system models (production model, consumption model), and integrated procedures (multi-agent simulation) to link human systems to natural systems; (2) to validate the reliability and the robustness of the database and the integrated modeling framework in selected study areas; and (3) to create a geo-coded spatial-temporal database for both human factors and natural factors.

This award reflects NSF's statutory mission and has been deemed worthy of support through evaluation using the Foundation's intellectual merit and broader impacts review criteria.

Call for Papers: Journal of Natural Resources Policy Research Special Issue: Institutional Entropy: Causes, Consequences and Corrective Measures

Guest Editors: Chennat Gopalakrishnan, University of Hawaii at Manoa, U.S.A; Jason Levy, University of Hawaii at West Oahu, U.S.A

Recent years have witnessed a significant increase in the decline and fall of natural resource (e.g., water, energy, forestry, minerals, fisheries) institutions in the US and globally, due to the corrosive impact of institutional entropy. The purpose of this special issue is to examine in detail the causes and consequences of institutional entropy and also suggest possible corrective measures.

Gopalakrishnan (2005) defines institutional entropy as "the progressive decrease in effectiveness and efficiency (of the institutions) in performing the goals and objectives as originally envisioned and setforth." He goes on to point out that the intrusion of entropy "causes disarray in the inner workings of the affected institutions and, thus, renders them diminished in their ability to perform at peak efficiency."

Entropy, slowly but surely, penetrates, corrodes, and compromises the efficiency and effectiveness of institutions and renders them dysfunctional, over a period of time. Gopalakrishnan, in his research-inprogress (2018-), has identified the key elements of institutional efficiency and effectiveness. These include: 1) institutional resilience or adaptability, 2) institutional robustness or diminished vulnerability, 3) institutional autonomy, 4) institutional relevance,
5) institutional accountability, 6) institutional risktaking, and 7) institutional innovation.

Institutions that fail to keep up with social, economic, technological, environmental, political, and cultural changes that inevitably accompany the passage of time, render themselves severely vulnerable to entropy. Depending on the intensity of entropy, several of the key attributes of institutional efficiency and effectiveness, noted above, are compromised and institutional sustainability is imperiled with the passage of time.

The objective of this special issue is to shed light on the process and progression of institutional entropy. We are seeking original contributions that will clarify and illuminate all aspects of institutional entropy, using historical surveys, institutional analysis, econometric investigations, empirical reviews, and more. Policy-rich, cross-disciplinary, and transnational papers, including case studies, are welcome.
