



We are delighted to have Lisa Schulte Moore, Professor of Landscape Ecology, Iowa State University, and a winner of the 2021 MacArthur Fellow Award as the speaker for the TW Schultz Memorial Lecture at the ASSA meetings, on January 8, 2022. Lisa has done pioneering work on designing and implementing locally relevant approaches to improve the sustainability of row crop agriculture. Her leadership is advancing new transdisciplinary approaches to co-produce knowledge that can be mobilized for action. I hope you will tune in to hear her virtual presentation.

We are continuing efforts to engage AAEA with other professional societies and disciplines to promote research and action on moving towards a more sustainable agricultural system. An upcoming webinar on "Transforming Food Systems for a Circular Economy" on Oct 27, 2021 at 1 pm Central Time, organized in conjunction with CFARE will bring leading thinkers to share their perspectives on this topic. preparation of issuing a call for submissions before the end of the year and bringing out the first issue in Spring 2022.

### **AAEA Trust Call for Proposals**

The AAEA Trust supports the work of agricultural and applied economists by funding programs, initiatives, activities or other creative endeavors designed to advance the profession. Proposals are chosen to receive funding based on their ability to accomplish at least one of the following goals:

- support graduate student and early career professional development
- enhance the AAEA Annual Meeting,
- broaden participation in AAEA across the year (beyond Annual meetings),

- address our strategic goal to be more inclusive through outreach to new groups,
- broaden the horizons of the current membership

Funds donated to the unrestricted and student and early career professional development categories of the AAEA Trust will be used to fund proposals approved by the AAEA Trust Committee and Executive Board. Proposals from AAEA Committees and Sections are encouraged. Please note that the Trust does not fund individual research projects, nor does it retroactively fund activities that have already taken place. Please contact Trust Committee Chair Dawn Thilmany at <a href="mailto:dawn.thilmany@colostate.edu">dawn.thilmany@colostate.edu</a> if you would like to discuss your proposal ideas before submission.

Proposal submissions should include:

- 1. A cover sheet with name of applicant; applicant's mailing address, e-mail, and phone number; title of the project; abstract of the project; timing, duration, and location of the project; and amount of funding requested.
- 2. A project description, not to exceed five double-spaced pages, including the purpose (and how that aligns with the goals above), scope, implementation procedures, the individuals responsible for management of the project, date/timing of the project, and location of the project.
- 3. An itemized budget, indicating costs to be borne by the Trust and funding provided by other sources, if any. The AAEA Business Office may be a resource for budget information. For this year, please share if COVID provided disruptions to previously planned activities and if this proposal addresses challenges presented to members, sections or the AAEA during COVID.

Proposals should be submitted as a single PDF file by **Friday, October 15, 2021**, to ensure consideration for funding for the next year. Proposals will be reviewed by the AAEA Trust Committee, which will make recommendations to the Executive Board for action at the January 2022 Board Meeting.

### Anthony Grano Fellowship Applications

The AAEA Trust is now accepting applications for the Anthony Grano Scholarship Award. Two scholarships of \$1,250 will be awarded to academically successful, highly motivated students in agricultural economics or a closely related discipline with an interest in agricultural policy and the policy formation process. The scholarship will support recipients to travel to Washington, DC to meet with senior staff from USDA, Congressional offices, and agricultural trade associations and commodity organizations.

Eligible applicants will be graduate students in either agricultural economics or economics with an agricultural emphasis in any U.S. university.

The application deadline is **Friday**, **October 15**, **2021**.

### Uma Lele AERA India/AAEA Mentorship Program

The AERA along with one representative from AAEA will play a facilitating role in the selection of Indian students/young professionals to participate in the mentorship program. The offer and themes for each year will be published in one of the issues of Agricultural Economics Research Review (AERR) and recommendation of the Association shall be sent to AAEA for Award of the grant. The following criteria were agreed for screening and recommendation of the candidate(s).

- a.) The program shall be open to doctoral and post-doctoral candidates and the maximum age of the candidate should not be more than 35 years
- b.) Masters/PhD degree in agricultural economics/economics with evident contribution to agricultural economics research
- c.) The candidate should give an undertaking to publish at least one research article in a journal of national/international repute as an outcome of the mentorship work

### Uma Lele Mentor Fellowship Award for Women

The Agricultural & Applied Economics Association (AAEA) Trust is now accepting applications for the Uma Lele Mentor Fellowship Award for Women. The Uma Lele Mentor Fellowship Award for Women supports a mentorship relationship between an early career woman agricultural, resource and environmental economist from low income and lower-middle income countries, and a mentor who is a member of the AAEA. A complete list of qualifying countries is available under the headings "Low-income economies" and "Lower-middle-income economies" at: <a href="http://data.worldbank.org/about/country-classifications/country-and-lending-groups#Low\_income">http://data.worldbank.org/about/country-classifications/country-and-lending-groups#Low\_income</a>.

The purpose of the award is to promote high quality research of a policy/problem solving nature, by fostering research collaboration between the scholar and mentor. Research topics should fall within the mission of the AAEA (<a href="www.aaea.org/about-aaea">www.aaea.org/about-aaea</a>), but preference will be given to topics focusing on countries that are facing food and nutrition insecurity, and/or environmental pressures.

The total amount of the award is up to USD \$5,000. Of this, up to USD \$4,500 will be allocated to the scholar and up to USD 500 to the mentor. The award to the scholar is intended to cover travel, registration, and related costs of the scholar to attend a meeting organized by the AAEA or the ICAE where both the mentor and the scholar can meet. The award may also be used to cover travel costs to the mentor's work place. The amount allocated to the mentor can be used for travel and other expenses during the fellowship period. The AAEA will waive registration fee for both the scholar and the mentor for the duration of the fellowship. AAEA will also waive annual membership fee for the scholar for the duration of the fellowship.

Women scholars, who are either within one year of obtaining a Ph.D. in Agricultural Economics, Economics, or related field, or within five years of having completed Ph.D. and are citizens of and reside in a low income and lower-middle income country are eligible to apply. Ph.D. students studying in countries that are not considered low-income economies and lower-middle-income economies may also apply, but they must be close to completing their degree and planning to permanently reside in a low-income or a lower-middle-income country by the end of 2022. Mentors can reside in any part of the world, but they must be AAEA members.

To apply, scholars should submit the following:

- Recent CV
- 2. Research proposal outlining the research project that the applicant will work on with his or her mentor (maximum 3 single-spaced pages). Applicants are advised to discuss the proposal with a prospective mentor before applying.
- 3. Letter of recommendation from the applicant's department head/supervisor stating that the institution supports the applicant's participation
- 4. Name and details of the mentor. If the scholar has not yet decided on a mentor, they may state this and seek input from the selection committee. The selection committee will make every attempt to help identify appropriate mentors but will do so only for the selected applicants.
- 5. Letter of intent to collaborate from the proposed mentor if the applicant already has a mentor.
- 6. Budget

# Call For Applications *Uma Lele Mentor Fellowship Award*

The Agricultural & Applied Economics Association (AAEA) Trust is now accepting applications for the Uma Lele Mentor Fellowship Award. The Uma Lele Mentor Fellowship Award supports a mentorship relationship with a view to promote high quality research of a policy/problem solving nature in countries with food insecurity and environmental pressures. It is meant to promote collaboration between an early career scholar who is a citizen of and resides in a developing country and a distinguished mentor.

The award is intended to cover the costs of travel and expenses for a scholar and mentor to work together on a specific research project in a high priority area for the scholar's country. The maximum fellowship grant will be \$5,000. Up to \$4,500 can be allocated for travel expenses for the scholar to visit the mentor's workplace and/or to meet with the mentor at a professional meeting. Up to \$1,500 can be allocated for mentor travel and other expenses during the fellowship period. Research topics should fall within the mission of the AAEA (www.aaea.org/about-aaea).

Scholars should be professional economists who are citizens of and reside in a developing country. A complete list of qualifying countries is available under the headings "Low-income economies" and "Lower-middle-income economies" at: <a href="http://data.worldbank.org/about/country-classifications/country-and-lending-groups#Low\_income">http://data.worldbank.org/about/country-classifications/country-and-lending-groups#Low\_income</a>. Scholars should either have completed their terminal degree or will complete it within the year. Students studying in countries that are not considered "low-income economies" and "lower-middle-income economies" may apply, but they must be completing their degree and planning to permanently reside in a "low-income" and "lower-middle-income" country by the end of 2022. Mentors can reside in any part of the world, but each must be an AAEA member.

### **AM22 Pre- and Post-conference Workshops**

The AAEA Executive Board invites proposals for Pre- and Post-conference Workshops at the 2022 AAEA Annual Meeting in Anaheim, CA. The deadline for proposals is **Thursday, December 2**. Submissions will be judged on the merits of the proposal and the space and time available at the Annual Meeting. Organizers will work with the AAEA Business Office to develop a budget for final approval at the January Board meeting.

Proposals should be submitted using the <u>Pre- and Post-conference Workshop Proposal form</u> available on the AAEA website, <u>https://www.aaea.org/meetings</u>, Title of proposed session and the proposed date and time that the workshop would take place (potential dates include **Saturday**, **July 30**, **and Wednesday**, **August 3**)

- 1. Objectives of the workshop, as well as the timeliness of the subject and why the content of the workshop is relevant to AAEA members/meeting attendees
- 2. Potential speakers, presenters, or panel members, and the total time required for these presentations.
- 3. Intended audience and expected attendance at the workshop
- 4. Contact information for organizers in charge of overall development and coordination (complete addresses, phone numbers, and e-mail addresses)
- 5. Complete budget information, which includes: financial support expected, speaker travel expenses, stipends, and honoraria, catering needs, administrative fees, and other income and costs. Detailed information will be needed, including any catering requests (e.g. boxed lunches, buffet, coffee breaks, etc.), so that a registration fee for the workshop can be determined
- 6. Any requests for membership and/or registration fee waivers that may be required in order to properly conduct the workshop
- 7. Any special software or electronic needs, including if the attendees will be required to bring a laptop

Incomplete proposals cannot be considered. Please include as much information as needed when submitting; there is no minimum or maximum length for the proposal.

### **Call for Proposals:**

### **AM22 Invited Paper Sessions**

AAEA welcomes proposals for Invited Paper sessions for the 2022 AAEA Annual Meeting in Anaheim, CA. Papers in these Invited Paper sessions may be published in the *Applied Economics Perspectives and Policy (AEPP)* in March 2023, subject to review. Proposals from individuals or groups need to be submitted using the online submission system by **Thursday, December 2, 2021**. The system will open in early November.

The most successful invited papers frame new areas of research, provide a systematic review of an existing area, or offer a novel perspective.

Proposed session formats must include either two papers with two discussants or three papers with one discussant. Four paper sessions will not be considered.

Proposals will be evaluated using the following criteria:

- The proposed session supports the objective of the Association to further the development and dissemination of systematic knowledge of agricultural and applied economics;
- The importance of the session is well-justified;
- The proposed papers are timely and the topics are likely to generate meaningful discussion during the presentation, as well as interest in a published version;
- It is likely that the session format will be conducive to a clear, focused, and informative presentation of the topics proposed;
- The session theme and paper topics are not repetitive of themes and/or topics previously addressed in Invited Paper sessions;
- The set of sessions will appeal to a broad spectrum of the membership.

Proposals should include session title and rationale, two-page abstracts and titles for each proposed presentation, and names and contact information of authors, discussants, and moderators.

The invited papers should be completed by **Thursday**, **April 7**, **2022**. These completed versions will be reviewed by the invited paper sessions committee, and feedback to improve the papers will be provided to the author(s). Final versions of the invited papers must be submitted to AAEA by **Wednesday**, **May 18**, **2022**. If the authors wish the invited paper to be reviewed for publication in the *AEPP*, it should also be submitted to the *AEPP* Editors via Editorial Express by **Wednesday**, **August 24**, **2022**.

### **Call for Abstracts**

### **AM22 Selected Presentation Papers and Posters**

AAEA seeks submissions for Selected Presentations for the 2022 AAEA Annual Meeting in Anaheim, CA. Selected Presentations are a submission category that represents both Selected Papers and Selected Posters. All submissions are reviewed and accepted together, and only after acceptance are the submissions designated as a paper or poster. At the time of submission, individuals will have the option for their submission to be considered as a poster only. There is no paper only option. Abstracts must be received by Wednesday, January 18, 2022 11:59 PM CST, and should be submitted using AAEA's online Abstract Management System. The system will open in early November.

Submissions for Selected Presentations must include a two-page, single-spaced abstract that provides a clear explanation of what will be presented at the Annual Meeting. Presenting author and co-authors should include in this abstract a discussion of the relevance of the topic, research methodology, and potential for generating discussion during the meeting. Please do not include your name or contact information in the abstract file.

### Tips for selecting a Subject Code for your abstract

When submitting your paper to the abstract system you will need to select a subject code. The subject code you select is the category your paper will be grouped in when being reviewed based on a common topic. If accepted, sessions are comprised of abstracts with the same subject codes. To assist you with selecting a subject code the Selected Presentations Committee created keywords for each of the subject codes. We recommend you refer to the keywords for subject codes to help you determine the subject code for your submission.

Abstracts must be received by Wednesday, January 18, 2022 11:59 PM CST, and should be submitted using AAEA's online Abstract Management System. Material previously presented at other meetings cannot be accepted, and the submitting author will be asked to verify that the material has not been presented elsewhere. When entering the title of your abstract, please be sure to submit it as you would like it to appear in the program – with proper capitalization and punctuation.

Review Process

All submissions are subjected to a common, double-blind review process. After the review process has been completed, topic leaders will construct coherent Selected Paper Sessions and Lightning Sessions based on a common topic. All remaining accepted presentations will be assigned as a poster. Presentation proposal acceptance notifications will be sent via email to presenters in March. Emails may be received in spam folders. Should you not find an email by mid-April, please feel free to contact the AAEA Business Office at <a href="mailto:info@aaea.org">info@aaea.org</a> or at (414) 918-3190.

### **Posters**

Poster presenters should be available during their assigned interval during the meeting for questions and discussion. The event program and mobile app will list the poster titles, authors, locations, and presentation time. Poster presenters must submit a PDF version of their poster to the AAEA submission site by May 19, 2022 11:59 PM CST. A cover page must be included before uploading. Please prepare a Cover Page using this template and append it to your pdf file before uploading. Please keep submissions under 4 MB. AAEA will upload these posters to the AgEcon Search. Posters that miss this deadline will be withdrawn from the program.

### Selected Paper Sessions and Lightning Sessions

Up to 8 papers are included in a 90-minute Lightning Session, and up to 4 papers are included in a 90-minute Selected Paper Session. Therefore, each paper presentation in a Lightning Session is allotted 9 minutes, with 7 minutes to present and 2 minutes for discussion. Likewise, each presentation in a Selected Paper Session is allotted 20 minutes, with 15 minutes for presentation and 5 minutes for discussion.

Presenters of Selected Papers must submit a full version of their paper to the AAEA submission site by May 19, 2022 11:59 PM CST. A cover page must be included before uploading. Please prepare a Cover Page using this template and append it to your pdf file before uploading. Please keep submissions under 4 MB. AAEA will upload these papers to the AgEcon Search. Papers that miss this deadline will be withdrawn from the program. The full version of the paper has no length limitations, but less than 25 pages is preferred. Double–spaced, 8.5 by 11-inch, single–sided format is requested. Please follow the American Journal of Agricultural Economics style guidelines, with the exception of the single table/figure per page convention.

### **Case Studies**

AAEA welcomes proposals for Case Studies for the 2022 AAEA Annual Meeting in Anaheim, CA. Cases in this Invited Paper session may be published in the *Applied Economics Teaching Resources* (*AETR*) in January 2023, subject to review. Proposals from individuals or groups need to be submitted using AAEA's online submission system by **Thursday, December 2, 2021**. The system will open in early November.

Proposals are requested for case studies that show how the application of economic principles to decision making in the public and/or private sectors leads to better decisions. Any topic area that illustrates the application of economic principles is acceptable. Topic areas focusing on emerging issues such as: renewable ingredients, energy economics, food safety, and company environmental policies (e.g., green scorecard) are encouraged.

Proposals will be evaluated using the following criteria:

- Deals with a problem that has a high level of importance/interest/relevancy to members of AAEA
- Clear and concise teaching objective(s) and target audience(s) (e.g. undergraduate students, graduate students, extension audiences)
- Case summary that presents solutions and explanations of how the learning objectives are realized
- Leads to a better understanding of how the application of economic principles improves decision making
- A general description of the teaching plan for presenting the case to include expected student use of reference materials

Proposals should include case title, names, contact information of the authors, and a case outline that covers the company or situation profiled, as well as a detailed outline for the case study. The outline should be 3-5 pages in length and a maximum of 2,000 words. The proposal must also contain an outline and ideas for a teaching note, although the teaching note will not be published with the case. Of the cases submitted, three winning case submissions will be accepted for presentation at the AAEA meetings by **March 10, 2022.** 

Selected case studies (with teaching note when applicable) should be completed by **Thursday, April 7, 2022.** These completed versions will be reviewed by the invited case study committee, and feedback to improve the cases will be provided to the author(s). Final versions of the cases must be submitted to AAEA by **Wednesday, May 18, 2022.** If the authors wish the case study to be reviewed for publication in the *AETR*, it should also be submitted to the *AETR* Editor by **Wednesday, May 18, 2022.** Accepted papers will carry a footnote that indicates they were subject to an expedited review process.

Examples of appropriate cases can be found in the agricultural and applied economics literature including the *American Journal of Agricultural Economics* (issues 94 (2) and 93 (2)), *International Food and Agribusiness Management Review* and the *Journal of the Food Distribution Research Society*. Applied Economics Perspectives and Policy

- 6. Disparities in federal and state funding at 1890 Land-Grant Institutions. Specifically, inequality in the distribution of funding support for research, teaching, and 4-H programs at 1890 institutions
- 7. Disparities by race in human capital development, income inequality, family/community resiliency, or disaster preparedness and their impacts on population and migration and/or rural and regional development, with a particular focus on the African American experience
- 8. Disparities by race in food security, with a particular focus on the African American experience
- 9. Black farmers' access to financial capital
- 10. Examination of alternative farm policy frameworks that continue systemic racism with government support and emergency payments. Black farmer participation levels in local food systems could be assessed in this context.

We welcome research papers, methods papers, case studies, or commentaries. Authors may employ qualitative, quantitative, or mixed methods approaches in researching both shortcomings and successes of programs.

### October 2021

### FY 2022 Appropriations Update

On September 30<sup>th</sup>, the Congress sent a Continuing Resolution to President Biden that would avoid a government shutdown. Biden signed the legislation, which funds the government through December 3<sup>rd</sup>, giving Congress some additional time to complete work on appropriations for fiscal year 2022. Congress is also continuing to debate raising the debt ceiling, investing in infrastructure and advancing a budget reconciliation package that would invest up to \$3.5 trillion in a wide variety of programs.

Below is a summary of key accounts within the agriculture appropriations bill and how they currently stand in the House and Senate versions:

### Agriculture Research Included in House Version of \$3.5 Trillion Budget Reconciliation Package

President Biden has proposed \$3.5 trillion in a broad spectrum of investments to advance his priorities. The House has begun work on filling out their version of the sweeping package and House committees have met to approve the provisions under their respective jurisdictions. The House Agriculture Committee has approved the investment of over \$65 billion to support agricultural research, rural development and forestry. The <a href="mailto:package">package</a> would invest \$7.75 billion in agricultural research to advance the American food and agriculture system's global competitiveness, innovation, infrastructure, food security, equity, and climate change resilience.

Highlights of the research investments include:

- \$3.65 billion Infrastructure through the Research Facilities Act
- \$100 million Research Equipment Grants
- \$380 million AGARDA (Agriculture Advanced Research & Development Authority)
- \$540 million Foundation for Food & Agriculture Research (FFAR)
- \$500 million Agriculture & Food Research Initiative (AFRI)
- \$500 million Sustainable Ag Research & Education (SARE)
- \$20 million Agriculture Genome to Phenome Initiative
- \$200 million OREI (Organic Research & Extension Initiative)
- \$600 million Smith-Lever (Extension)
- \$126 million Extension -1890s
- \$40 million Extension -1994s
- \$45 million Economic Research Service (ERS)
- \$14 million National Agricultural Statistics Service (NASS)
- \$16 million Office of the Chief Economist

While these potential investments in agricultural research are very encouraging, the outlook for the budget reconciliation remains unclear. Some Senate Democrats have expressed concerns about the overall price of the \$3.5 trillion package. Because the Senate is evenly split between Democrats and Republicans, it would require all Democrats to support the package to ensure passage. As a result, leaders in the House and Senate are currently negotiating how to move forward. If the size of the budget reconciliation package is decreased, it is unclear what impact that would have on the agriculture section.
