

President's Column



I'm pleased to announce a generous \$150,000 grant from the USDA-ERS to the Association in support of AAEA professional development activities with a focus on strengthening the skills of new members of the profession. We aim to expand the diversity of the profession across many dimensions; including the types of careers and backgrounds of members and build ties between individuals from different institutions. The funds will be used to help support workshops such as the Early Career Professional Symposium that will be held this summer, and more generally, we will be able to expand travel grants to the summer meetings and other symposia and workshops. We are also working to expand the resources available on the newly created [Online Mentorship Portal](#), and to re-ignite the successful one-on-one mentorship program held in previous years. Many thanks to ERS!

The aforementioned symposium is just one example of the kinds of activities AAEA encourages and supports. Have an idea for a meeting but don't want to deal with all the logistical headaches? [Submit a proposal](#) for a symposium and let the AAEA business office help with the logistical details. We can even help provide some financial support or travel grants. Sometimes the symposium route is not quite the right fit for every

activity, so we also offer the opportunity for [AAEA Workshops](#) and even [AAEA Endorsed Events](#).

One might wonder where the money is coming from to help sponsor such activities. As you might have noticed, the AAEA budget has been running at a deficit for the past couple of years. This is on purpose. We have enough reserves in the bank to cover three years of operating expenses, and a couple years ago we were in the fortunate position of receiving some larger-than-expected payouts from our contract with Oxford University Press. Past AAEA board members have made decisions to spend down a portion of these reserves on strategic activities such as mentoring, symposia, government relations, and outreach (mainly C-FARE), and on media and communication. We will ultimately have to bring the budget back into balance, but we are hopeful the current expenditures will have long-term payoffs for members of the association.

Speaking of media and communication, we want to promote your work. But, we need your help. If you have recently been in the news, let the [AAEA business office](#) know. In addition, we have initiated efforts to generate press releases for selected *AJAE* and *AEPP* articles prior to publication. If you are contacted by the AAEA business office about one of your articles, help us tell your story. I am a firm believer that our profession does important work relevant to multiple stakeholders. However, the work is useless unless people know about it.

Planning is already underway for the 2017 AAEA Annual Meeting in Chicago. We are likely to tinker a bit with the schedule for reunions, posters, and other activities in an effort to improve the meeting experience. Be on the lookout in the near future for the call for invited papers.

Finally, I recently had the opportunity to participate in the planning and strategy meetings with Oxford University Press and the editors of *AEPP* and *A/AE*. We are fortunate to have a dedicated group of skilled editors. Spiro Stefanou and Terry Hurley will soon be rolling off as editors of the *AEPP* and will be replaced by Craig Gundersen and Chris McIntosh. For the *A/AE*, Junjie Wu and Jim

Vercammen will be finishing up their term at the end of the year, and we will soon start the search for their replacements. Submissions to the journals and downloads to papers in the journals continue to climb. We are continuing to investigate ways to improve the impact of the journals and explore whether our current offerings are meeting the needs of the profession.

As always, I welcome your suggestions and comments.

2. A project description, not to exceed five double-spaced pages, including the purpose, scope, implementation procedures, the individuals responsible for management of the project, date/timing of the project, and location of the project.

3. An itemized budget, indicating costs to be borne by the Trust and funding provided by other sources, if any. The AAEA Business Office may be a resource for budget information.

Proposals should be submitted as a single PDF file by **Monday, October 17, 2016**, to ensure consideration for funding for the next year. Proposals will be reviewed by the AAEA Trust Committee, which will make recommendations to the Executive Board for action at the January 2017 Board Meeting.

Uma Lele Mentor Fellowship Award:
Call For Applications

The Agricultural & Applied Economics Association (AAEA) Trust is now accepting applications for the Uma Lele Mentor Fellowship Award. The Uma Lele Mentor Fellowship Award supports a mentorship relationship with a goal to promote high quality research of a policy/problem solving nature in countries with food insecurity and environmental pressures. It is meant to promote collaboration between an early career scholar who is a citizen of and resides in a developing country and a distinguished mentor.

The award is intended to cover the costs of travel and expenses for a scholar and mentor to work together on a specific research project in a high priority area for the scholar's country. The maximum fellowship grant will be \$5,000. Up to \$4,500 can be allocated for travel expenses for the scholar to visit the mentor's workplace and/or to meet with the mentor at a professional meeting. Up

to \$1,500 can be allocated for mentor travel and other expenses during the fellowship period. Research topics should fall within the mission of the AAEA (www.aaea.org/about-AAEA).

Scholars should be professional economists who are citizens of, and reside in, a developing country. A complete list of qualifying countries is available under the headings "Low-income economies" and "Lower-middle-income economies" at: http://data.worldbank.org/about/country-classifications/country-and-lending-groups#Low_income. Scholars should either have completed their terminal degree or will complete it within the year. Students studying in countries that are not considered "low-income economies" and "lower-middle-income economies" may apply, but they must be completing their degree and planning to permanently reside in a "low-income" and "lower-middle-income" country by the end of 2016.

Mentors can reside in any part of the world, but each must be an AAEA member.

To apply, scholars should submit the following:

1. Cover letter outlining proposed plan for mentorship, including contact information for the mentor, proposed dates and nature of the research project and collaboration, and outputs expected
2. Recent CV
3. Research proposal outlining the research project that the applicant will work on with his or her mentor (maximum 3 single-spaced pages)

4. Letter of recommendation from the applicant's department head/supervisor stating that the institution supports the applicant's participation
5. Letter of intent to collaborate from the proposed mentor
6. Budget

2017 EAAE in Parma, Italy:

Call for Contributions

Agri-food systems in Europe and elsewhere often face conflicting incentives and signals arising from markets and society, and need to make trade-offs. Sustainability advocacy groups are putting societal concerns like animal welfare, food safety, cultural heritage, food sovereignty, and carbon footprint on the agenda of policy makers and stakeholders in the food value chain. However, there are many challenges to overcome, especially when more sustainable food systems face conflicting goals, and households' purchasing decisions are mainly price-driven.

Policy makers, therefore, face increasing challenges in balancing these concerns. The nature of challenges has changed over time with new technologies becoming available, with the ongoing innovation and transition to the bio-based economy, with an increasing share of the population living in urban areas, and with many markets becoming global. Some of these changes are subtle as borders between rural and urban areas are gradually disappearing, and cities are

integrating agricultural activities within their boundaries.

The European Association of Agricultural Economists (EAAE) scientific community is key to providing insights into the economic challenges and opportunities arising from the changing expectations and requirements from markets and society on agriculture. The XV EAAE Congress aims to foster discussion and interaction among scholars with representatives from business, society and policy agencies.

The EAAE board has appointed the [Program Committee](#) to organize the scientific program of the Congress. The [Local Organizing Committee](#) and the Program Committee are striving to arrange a very stimulating and innovative Congress program consisting of organized sessions, organized panels, invited plenary presentations, contributed papers, posters, as well as field trips.

In particular, policy makers, societal stakeholders, and agribusiness representatives shall contribute to the program through organized panels which have an open format and do not require a scientific paper. Organized panels could be thought as sort of a "round table" discussion, moderated by an "external" figure to the presenting/debating panelists, which may also feature one or two presentations by academics. A formal scientific paper is not required to encourage the participation by NGOs, producer/industry groups representatives, or any other stakeholder who may not be accustomed to submitting a formal paper. A four-person panel, in which academia, industry, NGO/stakeholder/societal groups and policy representatives are present and deliver their presentation/speech for 15 minutes each, may be the best format. The remaining 30 minutes could be employed for discussion – solicited by the moderator – or for answering questions from the audience. In order to facilitate stakeholder participation



to the organized panels daily participation fees will be foreseen, in case a one day presence is anticipated. Hopefully, the XV EAAE Congress in Parma will provide an interactive platform for researchers and representatives from non-academic institutions.

The SCC-76 "Economics and Management of Risks in Agriculture and Natural Resources" Group is soliciting submissions for the 2017 Annual Meeting, taking place March 30 – April 1, 2017, in Pensacola Beach, FL.

The objective of the conference is to provide a forum to facilitate the exchange of applied approaches to risk analysis, economics, and policy – both empirical and theoretical – as well as to nurture the development and application of dynamic and original research efforts related to agriculture and natural resources. Applied work in domains of government, industry, and academia are most welcome.

Abstracts should normally not exceed two double-spaced pages and should outline the research question, methodology, and results of the research.

Authors are welcome to submit abstracts for finished papers as well as papers in the early stages of development. All papers relevant to risk in agricultural and applied economics and their constituent fields will be considered. When submitting a paper, please indicate whether you would like a discussant. Requesting a discussant means you agree to discuss another paper.

Abstracts should be submitted by email (PDF only) no later than **December 15, 2016**, to abstracts@agriskgroup.org. Authors will be informed whether their papers are accepted by December 23, 2016. If a discussant is requested, a draft paper will be due by March 1, 2017.
