The AAEA Nominating Committee is soliciting nominations from AAEA membership for AAEA President-Elect and two AAEA Directors, all for three year terms beginning July 2021.

Call for Nominations 2022 Fellows Award Nominations

The AAEA Fellows Selection Committee is inviting nominations for the 2022 AAEA Fellows Awards. The deadline for submission of nominations and supporting biographical documentation is **Wednesday**, **October 6**, **2021**. Selection is based mainly on a continuous contribution to the advancement of agricultural or applied economics as defined by the Vision Statement of the AAEA. Achievements may be in research, teaching, extension, administration, or business. The nominee must be a living current member of AAEA and have been a member for at least five years.

Please follow these guidelines to submit Fellows nominations (non-complying materials will be returned). The nomination package should focus on documentation of the case for the nominee's contributions rising to a level that warrants recognition as a Fellow. "Continuous contribution" means exceptional service over a period of years. Such exceptional service may be demonstrated by: research discoveries published in major professional journals; leadership in the development of extension programs extensively utilized by other professionals; the development of undergraduate or graduate programs of learning that have become nationally recognized professionally and by students who have, in turn, demonstrated success as a result of these teaching programs; contributions to advance diversity, equity and inclusion objectives in the broader profession through for example, teaching, research collaboration, professional leadership, or outreach to, engagement with, and mentoring of individuals from underrepresented groups; or outstanding performance in government, business, or NGOs. As a general principle, continuous service means more than a single act that might be rewarded by an outstanding journal article, extension, or teaching award. The documentation for the nominee provided should make clear the impact of the individual nominated in the areas of achievement to which the nominee has contributed. This evidence could include, but is not limited to, reference to publications, awards, honors, reports, testimonials to notable tasks undertaken and outcomes achieved, or other contributions to the profession.

Members of the Fellows Selection Committee and AAEA Executive Committee (President-Elect, President, or Past President) may not nominate or provide support statements for nominees. Nomination packages that include support statements from a member of the Fellows Selection Committee and/or the AAEA Executive Committee will be sent back to the nominator for revisions.

Testimonial letters or vitae are not required. The total nomination package should be limited to a maximum of eight typed pages using 12-point font and with margins of at least one inch on all four sides. All material must be double-spaced. Please include the name, institution, and contact information of all of the nominators within the eight page package. Nominations should be submitted as a single PDF file to Allison Ware at aware@aaea.org. Please contact Allison if you have any questions.

The 2022 Fellows Recognition Ceremony will be held as part of the 2022 AAEA Annual Meeting in Anaheim, CA. Information on previous AAEA Fellows and the procedures used to select Fellows is available on the <u>AAEA</u> Fellows page.

Proposal submissions should include:

- 1. A cover sheet with name of applicant; applicant's mailing address, e-mail, and phone number; title of the project; abstract of the project; timing, duration, and location of the project; and amount of funding requested.
- 2. A project description, not to exceed five double-spaced pages, including the purpose (and how that aligns with the goals above), scope, implementation procedures, the individuals responsible for management of the project, date/timing of the project, and location of the project.
- 3. An itemized budget, indicating costs to be borne by the Trust and funding provided by other sources, if any. The AAEA Business Office may be a resource for budget information. For this year, please share if COVID provided disruptions to previously planned activities and if this proposal addresses challenges presented to members, sections or the AAEA during COVID.

Proposals should be submitted as a single PDF file by **Friday, October 15, 2021**, to ensure consideration for funding for the next year. Proposals will be reviewed by the AAEA Trust Committee, which will make recommendations to the Executive Board for action at the January 2022 Board Meeting.

Anthony Grano Fellowship Applications

Uma Lele AERA India/AAEA Mentorship Program

The AERA along with one representative from AAEA will play a facilitating role in the selection of Indian students/young professionals to participate in the mentorship program. Uma Lele Mentor Fellowship Award for Women

The Agricultural & Applied Economics Association (AAEA) Trust is now accepting applications for the Uma Lele Mentor Fellowship Award for Women. The Uma Lele Mentor Fellowship Award for Women supports a mentorship relationship between an early career woman agricultural, resource and environmental economist from low income and lower-middle income countries, and a mentor who is a member of the AAEA. A complete list of qualifying countries is available under the headings "Low-income economies" and "Lower-middle-income economies" at: http://data.worldbank.org/about/country-classifications/country-and-lending-groups#Low_income.

The purpose of the award is to promote high quality research of a policy/problem solving nature, by fostering research collaboration between the scholar and mentor. Research topics should fall within the mission of the AAEA (www.aaea.org/about-aaea), but preference will be given to topics focusing on countries that are facing food and nutrition insecurity, and/or environmental pressures.

The total amount of the award is up to USD \$5,000. Of this, up to USD \$4,500 will be allocated to the scholar and up to USD 500 to the mentor. The award to the scholar is intended to cover travel, registration, and related costs of the scholar to attend a meeting organized by the AAEA or the ICAE where both the mentor and the scholar can meet. The award may also be used to cover travel costs to the mentor's work place. The amount allocated to the mentor can be used for travel and other expenses during the fellowship period. The AAEA will waive registration fee for both the scholar and the mentor for the duration of the fellowship. AAEA will also waive annual membership fee for the scholar for the duration of the fellowship.

Women scholars, who are either within one year of obtaining a Ph.D. in Agricultural Economics, Economics, or related field, or within five years of having completed Ph.D. and are citizens of and reside in a low income and lower-middle income country are eligible to apply. Ph.D. students studying in countries that are not considered low-income economies and lower-middle-income economies may also apply, but they must be close to completing their degree and planning to permanently reside in a low-income or a lower-middle-

income country by the end of 2022. Mentors can reside in any part of the world, but they must be AAEA members.

To apply, scholars should submit the following:

- 1. Recent CV
- 2. Research proposal outlining the research project that the applicant will work on with his or her mentor (maximum 3 single-spaced pages). Applicants are advised to discuss the proposal with a prospective mentor before applying.
- 3. Letter of recommendation from the applicant's department head/supervisor stating that the institution supports the applicant's participation
- 4. Name and details of the mentor. If the scholar has not yet decided on a mentor, they may state this and seek input from the selection committee. The selection committee will make every attempt to help identify appropriate mentors but will do so only for the selected applicants.
- 5. Letter of intent to collaborate from the proposed mentor if the applicant already has a mentor.

Call For Applications *Uma Lele Mentor Fellowship Award*

The Agricultural & Applied Economics Association (AAEA) Trust is now accepting applications for the Uma Lele Mentor Fellowship Award supports a mentorship relationship with a view to promote high quality research of a policy/problem solving nature in countries with food insecurity and environmental pressures. It is meant to promote collaboration between an early career scholar who is a citizen of and resides in a developing country and a distinguished mentor.

The award is intended to cover the costs of travel and expenses for a scholar and mentor to work together on a specific research project in a high priority area for the scholar's country. The maximum fellowship grant will be \$5,000. Up to \$4,500 can be allocated for travel expenses for the scholar to visit the mentor's workplace and/or to meet with the mentor at a professional meeting. Up to \$1,500 can be allocated for mentor travel and other expenses during the fellowship period. Research topics should fall within the mission of the AAEA (www.aaea.org/about-aaea).

Scholars should be professional economists who are citizens of and reside in a developing country. A complete list of qualifying countries is available under the headings "Low-income economies" and "Lower-middle-income economies" at: http://data.worldbank.org/about/country-classifications/country-and-lending-groups#Low_income. Scholars should either have completed their terminal degree or will complete it within the year. Students studying in countries that are not considered "low-income economies" and "lower-middle-income economies" may apply, but they must be completing their degree and planning to permanently reside in a "low-income" and "lower-middle-income" country by the end of 2022. Mentors can reside in any part of the world, but each must be an AAEA member.

- 4. Contact information for organizers in charge of overall development and coordination (complete addresses, phone numbers, and e-mail addresses)
- 5. Complete budget information, which includes: financial support expected, speaker travel expenses, stipends, and honoraria, catering needs, administrative fees, and other income and costs. AM22 Invited Paper Sessions

AAEA welcomes proposals for Invited Paper sessions for the 2022 AAEA Annual Meeting in Anaheim, CA. Papers in these Invited Paper sessions may be published in the *Applied Economics Perspectives and Policy (AEPP)* in March 2023, subject to review. Proposals from individuals or groups need to be submitted using the online submission system by **Thursday, December 2, 2021**. The system will open in early November.

The most successful invited papers frame new areas of research, provide a systematic review of an existing area, or offer a novel perspective.

Proposed session formats must include either two papers with two discussants or three papers with one discussant. Four paper sessions will not be considered.

Proposals will be evaluated using the following criteria:

- The proposed session supports the objective of the Association to further the development and dissemination of systematic knowledge of agricultural and applied economics;
- The importance of the session is well-justified;
- The proposed papers are timely and the topics are likely to generate meaningful discussion during the presentation, as well as interest in a published version;
- It is likely that the session format will be conducive to a clear, focused, and informative presentation of the topics proposed;
- The session theme and paper topics are not repetitive of themes and/or topics previously addressed in Invited Paper sessions;
- The set of sessions will appeal to a broad spectrum of the membership.

Proposals should include session title and rationale, two-page abstracts and titles for each proposed presentation, and names and contact information of authors, discussants, and moderators.

The invited papers should be completed by **Thursday**, **April 7**, **2022**. These completed versions will be reviewed by the invited paper sessions committee, and feedback to improve the papers will be provided to the author(s). Final versions of the invited papers must be submitted to AAEA by **Wednesday**, **May 18**, **2022**. If the authors wish the invited paper to be reviewed for publication in the *AEPP*, it should also be submitted to the *AEPP* Editors via Editorial Express by **Wednesday**, **August 24**, **2022**.

Call for Abstracts

AM22 Selected Presentation Papers and Posters

AAEA seeks submissions for Selected Presentations for the 2022 AAEA Annual Meeting in Anaheim, CA. Selected Presentations are a submission category that represents both Selected Papers and Selected Posters. All submissions are reviewed and accepted together, and only after acceptance are the submissions designated as a paper or poster. At the time of submission, individuals will have the option for their submission to be considered as a poster only. There is no paper only option. Abstracts must be received by Wednesday, January 18, 2022 11:59 PM CST, and should be submitted using AAEA's online Abstract Management System. The system will open in early November.

Submissions for Selected Presentations must include a two-page, single-spaced abstract that provides a clear explanation of what will be presented at the Annual Meeting. Presenting author and co-authors should include in this abstract a discussion of the relevance of the topic, research methodology, and potential for generating discussion during the meeting. Please do not include your name or contact information in the abstract file.

Tips for selecting a Subject Code for your abstract

When submitting your paper to the abstract system you will need to select a subject code. The subject code you select is the category your paper will be grouped in when being reviewed based on a common topic. If accepted, sessions are comprised of abstracts with the same subject codes. To assist you with selecting a subject code the Selected Presentations Committee created keywords for each of the subject codes. We recommend you refer to the keywords for subject codes to help you determine the subject code for your submission.

Abstracts must be received by Wednesday, January 18, 2022 11:59 PM CST, and should be submitted using AAEA's online Abstract Management System. Material previously presented at other meetings cannot be accepted, and the submitting author will be asked to verify that the material has not been presented elsewhere. When entering the title of your abstract, please be sure to submit it as you would like it to appear in the program – with proper capitalization and punctuation.

Review Process

All submissions are subjected to a common, double-blind review process. After the review process has been completed, topic leaders will construct coherent Selected Paper Sessions and Lightning Sessions based on a common topic. All remaining accepted presentations will be assigned as a poster. Presentation proposal acceptance notifications will be sent via email to presenters in March. Emails may be received in spam folders. Should you not find an email by mid-April, please feel free to contact the AAEA Business Office at info@aaea.org or at (414) 918-3190.

Posters

Poster presenters should be available during their assigned interval during the meeting for questions and discussion. The event program and mobile app will list the poster titles, authors, locations, and presentation time. Poster presenters must submit a PDF version of their poster to the AAEA submission site by May 19, 2022 11:59 PM CST. A cover page must be included before uploading. Please prepare a Cover Page using this template and append it to your pdf file before uploading. Please keep submissions under 4 MB. AAEA will upload these posters to the AgEcon Search. Posters that miss this deadline will be withdrawn from the program.

Selected Paper Sessions and Lightning Sessions

Up to 8 papers are included in a 90-minute Lightning Session, and up to 4 papers are included in a 90-minute Selected Paper Session. Therefore, each paper presentation in a Lightning Session is allotted 9 minutes, with 7 minutes to present and 2 minutes for discussion. Likewise, each presentation in a Selected Paper Session is allotted 20 minutes, with 15 minutes for presentation and 5 minutes for discussion.

Presenters of Selected Papers must submit a full version of their paper to the AAEA submission site by May 19, 2022 11:59 PM CST. A cover page must be included before uploading. Please prepare a Cover Page using this template and append it to your pdf file before uploading. Please keep submissions under 4 MB. AAEA will upload these papers to the AgEcon Search. Papers that miss this deadline will be withdrawn from the program. The full version of the paper has no length limitations, but less than 25 pages is preferred. Double-spaced, 8.5 by 11-inch, single-sided format is requested. Please follow the American Journal of Agricultural Economics style guidelines, with the exception of the single table/figure per page convention.

Submit your Selected Presentation in the online Abstract Management System. The system will open in early November.

AAEA seeks submissions for Organized Symposia for the 2022 AAEA Annual Meeting in Anaheim, CA. Proposals are due by **Wednesday, January 18, 2022**, and should be submitted using AAEA's online submission system. The system will open in early November.

Organized Symposium sessions highlight ideas or works-in-progress on a topic involving cooperative or competing efforts by two or more panelists. Symposia may involve panel discussions of prepared questions, debates, roundtable meetings, or other formats. Formal paper presentations are discouraged, nonetheless if such presentations are proposed, the organizer should explain how they will fit into a tightly coherent theme. In all cases, at least half of the session time should be reserved for discussion among the panelists and between the panelists and the audience.

Symposia may offer discussions of policy issues, research methods, emerging research results, teaching or outreach topics, issues in professional organization, or other matters. Proposals should include: session title, session rationale, names and contact information for the organizer and other participants, and a description of the symposium format that includes plans for discussion.

At least one proposer for the organized symposium must be a member of AAEA, and all presenters, speakers, and/or discussants at the Annual Meeting must be members of AAEA and registered for the Annual Meeting by Thursday, May 18, 2022.

Topic areas focusing on emerging issues such as: renewable ingredients, energy economics, food safety, and company environmental policies (e.g., green scorecard) are encouraged.

Proposals will be evaluated using the following criteria:

- Deals with a problem that has a high level of importance/interest/relevancy to members of AAEA
- Clear and concise teaching objective(s) and target audience(s) (e.g. undergraduate students, graduate students, extension audiences)
- Case summary that presents solutions and explanations of how the learning objectives are realized

 Leads to a better understanding of how the application of economic principles improves decision making

 A general description of the teaching plan for presenting the case to include expected student use of reference materials

Proposals should include case title, names, contact information of the authors, and a case outline that covers the company or situation profiled, as well as a detailed outline for the case study. The outline should be 3–5 pages in length and a maximum of 2,000 words. The proposal must also contain an outline and ideas for a teaching note, although the teaching note will not be published with the case. Of the cases submitted, three winning case submissions will be accepted for presentation at the AAEA meetings by **March 10, 2022.**

Selected case studies (with teaching note when applicable) should be completed by **Thursday, April 7, 2022.** These completed versions will be reviewed by the invited case study committee, and feedback to improve the cases will be provided to the author(s). Final versions of the cases must be submitted to AAEA by **Wednesday, May 18, 2022.** If the authors wish the case study to be reviewed for publication in the *AETR*, it should also be submitted to the *AETR* Editor by **Wednesday, May 18, 2022.** Accepted papers will carry a footnote that indicates they were subject to an expedited review process.

Examples of appropriate cases can be found in the agricultural and applied economics literature including the *American Journal of Agricultural Economics* (issues 94 (2) and 93 (2)), *International Food and Agribusiness Management Review* and the *Journal of the Food Distribution Research Society*. Applied Economics Perspectives and Policy

The editors of AEPP invite authors to submit articles for a special issue on inequities and discrimination faced by African Americans in the United States related to topics within agricultural and applied economics. AEPP publishes research related to agriculture; animal, plant, and human health; energy; environment; food and consumer behavior; international development; natural hazards, natural resources; population and migration; and regional and rural development. In this Special Issue, we are particularly interested in the intersection of these topics with inequities and discrimination faced by African Americans. Possible topics for papers in this issue include, but are not limited to:

1. Implications of the Pigford v. Glickman suit and related cases on Black farmer land loss

2. Funding differences in experiment stations and extension systems between 1862 and 1890 institutions and impacts on African American outcomes related to food and agriculture

- 3. Evaluation of differences in intergenerational mobility of African American students between 1890 and 1862 institutions
- 4. Implications of agricultural land loss on present-day wealth and wealth-related disparities
- 5. Racial disparities, property values, and Black and white farmers in rural America
- 6. Disparities in federal and state funding at 1890 Land-Grant Institutions. Specifically, inequality in the distribution of funding support for research, teaching, and 4-H programs at 1890 institutions
- 7. Disparities by race in human capital development, income inequality, family/community resiliency, or disaster preparedness and their impacts on population and migration and/or rural and regional development, with a particular focus on the African American experience
- 8. Disparities by race in food security, with a particular focus on the African American experience
- 9. Black farmers' access to financial capital
- 10. Examination of alternative farm policy frameworks that continue systemic racism with government support and emergency payments. Black farmer participation levels in local food systems could be assessed in this context.

Authors may also report on lasting impacts of programmatic shortcomings or innovations on minority students, alumni, faculty, and the profession. We encourage research that implements the collective trauma recovery framework, weaver-leader framework, active and learner-centered pedagogy, traditional and remote classroom environments, and personal or group narratives. We welcome research papers, methods papers, case studies, or commentaries. Authors may employ qualitative, quantitative, or mixed methods approaches in researching both shortcomings and successes of programs.

Senate Appropriations Committee Approves FY 2022 Agriculture Bill

On August 4th, the Senate Appropriations Committee approved its version of the fiscal year 2022 appropriations bill for the Department of Agriculture and Food and Drug Administration. The bill provides discretionary funding of \$25.855 billion, which is an increase of \$2.5 billion over fiscal year 2021 enacted levels.

For agricultural research, total funding at USDA would be increased by \$292 million over fiscal year 2021 for a total of \$3.6 billion. The Agricultural Research Service is funded at \$1.67 billion and includes requested funding to address climate change. The bill also fully funds the National Bio and Agro Defense Facility. The National Institute of Food and Agriculture is funded at \$1.7 billion with increases for Cooperative Extensive Service, Agriculture and Food Research Initiative, Women and Minorities in STEM program, and several increases for tribal research and education. ERS would receive \$90.8 million, a \$5 million increase over FY 2021. NASS is slated to receive \$191.6 million, just under \$8 million more than FY 2021.

When compared to the House, ERS, NASS, and ARS would receive larger increases under the Senate bill than the House bill. For NIFA, Hatch and Smith Lever fare slightly better in the Senate than the House, while AFRI is funded at a higher level by the House. Below is a summary of key accounts comparing FY 2021 Final with amounts approved by the House and Senate.

The next step in the process is full Senate consideration of the agriculture appropriations bill. The House passed its version as a part of a multi-appropriations bill package in late July. As has been common in recent years, it appears unlikely that the House and Senate will reconcile and approve a final version of the FY 2022 agriculture appropriations bill before the end of the fiscal year on September 30th. A continuing resolution will likely be needed to keep the government funded as Congress works to complete the agriculture and other spending bills for FY 2022.


