# AAEA Trust Profile: Carola Grebitus

AAEA Trust Profile is a bi-monthly series following up with <u>AAEA Trust</u> sponsored scholarship, fellowship, and grant winners. This issue features Carola Grebitus, Assistant Professor of Food Industry Management, Morrison School of Agribusiness, W.P. Carey School of Business. Carola won the <u>Sylvia</u> <u>Lane Mentor Fellowship</u> in 2011. The Lane Mentor Fellowship provides an opportunity for young female scholars working on food, agricultural, or resource issues to collaborate with an established expert at another university, institution, or firm.

How did winning the Lane Mentor Fellowship help in accomplishing your research in measuring consumers' willingness to pay for local foods and food miles?



The Lane Mentor Fellowship enabled me to work together with Jayson Lusk and to visit Oklahoma State University where we worked intensively on two manuscripts

we published from that project. I learned a lot from Jayson in terms of experimental economics and how to run experiments successfully. In our field, experience is important and Jayson always offers advice.

When you were at University of Bonn your research involved consumer behavior – with a focus on new technologies, food safety, health, and sustainability. Is that still your main research focus? I still do a lot of work in these areas; although currently, my main focus lies on more theoretical questions regarding decision making. However, I always try to make an applied research contribution, too. Usually this contribution is either related to the economics of food choice and health or to sustainable decision making from a consumer's perspective.

#### Your mentor when you received the funding was Jayson Lusk from Oklahoma State University; do you still work or collaborate with him?

I believe that Jayson's mentoring was key for me in getting my current position at Arizona State University. Jayson and I still collaborate but currently more with regards to organizing conferences and workshops such as the 2nd AAEA/EAAE Symposium on 'Food Environment: The Effects of Context on Food' in 2012 in Boston, MA and the 2014 EAAE pre-congress workshop on 'Recent Trends in Experimental Economics'.

We encourage all AgEcon Search authors to take advantage of the RePEc Author Service.

One big benefit is a monthly e-mail that includes the number of abstract views and file downloads for your papers listed in RePEc (Research Publications in Economics) http://repec.org/

Citations to all documents in AgEcon Search are harvested by RePEc and the Author Service maintains a publication list from which your monthly e-mail is generated.

To get started, go to <u>https://authors.repec.org/</u> to register.

The registration process has 2 steps: 1. Enter your e-mail address, select a password, and tell the system which publications are yours.

2. Reply to the confirmation e-mail that will be sent to you shortly afterwards.

#### **AAEA/AARES Heading South Call for Applications**

We are pleased to invite submissions for the 2014 Heading South Award.

The Australian Agricultural and Resource Economics Society (AARES) and the Agricultural & Applied Economics Association (AAEA) through the AAEA Trust will jointly offer this travel award to attend the 2015 AARES Conference in Rotorua, New Zealand. It is available to members of AARES or AAEA normally resident in North America. Applicants for the award can be a member of either AARES or AAEA but must be a member of AARES to participate in the conference.

The objective of the award is to provide the winner with an opportunity for professional and personal development and international professional and cultural exchange. The award will have a value of \$3,000 USD to be used to assist the winner to participate in the **2015 Annual Conference of AARES to be held in Rotorua, New Zealand from February 10–13, 2015**.

#### **Selection Process**

The 2014 Heading South Selection Committee will be chaired by the AAEA President, Barry Goodwin. Other members will include the President-Elect of AARES, Prof. Alan Randall, another member of AARES, usually the president of the North America Branch, and another member of AAEA.

Applications should include:

- a paper for presentation at the AARES Annual Conference in Rotorua, for which the applicant is the sole or first author and which represents their original and unpublished work,
- a one-page biographical statement, and
- a one-page statement in support of their application, indicating what they would hope to accomplish through the award, why they would be deserving of the award, and confirming that they would be unable to attend the conference without this financial support.

#### **Submission Deadlines and Details**

Electronic submissions (in PDF form) for this award must be emailed to Brian Mondragón Jones (<u>bmjones@aaea.org</u>) by Friday, August 29, 2014 (for travel in February 2015).
