Message from the Chair

Greetings, I want to thank COSBAE's membership for allowing me to serve as your Chair, over the past year. I have found this experience to be very beneficial. Through this message, I want to report that COSBAE is "alive and well." Additionally, I will briefly share some Chair's goals, progress to date, and look at some of our opportunities and challenges.

When I accepted the chair, my primary goal was to foster increased membership, participation, and team work. Our previous leaders had done an outstanding job of increasing visibility and viability of COSBAE. The American Association of Agricultural Economics (AAEA) and other professional associations recognize us and make attempts to include our members on committees and to some degree on programs. Our long term growth depends, in part, on developing an internal operating process. Strategies employed included have regular executive committee telephone conference calls, and developing a formal committee structure to include both executive committee and at-large members in program development and implementation. This process continues to evolve. We have had several productive conference calls with excellent participation. COSBAE had strong participation at the Professional Agricultural Workers' Conference at Tuskegee University, December 1997 and SAEA, February 1998. I was tremendously pleased with the large number of graduate students. To the graduate students and their advisors, keep up the good work. Based on my best information COSBAE will, be well represented on the program at our summer meeting in Utah. Please review the program and support your colleagues.

The final issue is that of determining what our presence should/must be at the 1999 AAEA annual meeting in Nashville, Tennessee. These meetings are being held in the South, where most of the 1890 Colleges are, and where many of the issues (welfare to work, rural and economic development, small landholders agriculture, affirmative action, etc.) are prevalent that of concern to the nation and our membership. These meeting will provide an opportunity for COSBAE to develop a program (preconference, invited sessions, etc.) to address the set of these issues. This could be a good time to collaborate with other social scientists, policy makers and government leaders to provide a national or regional forum. The challenge is having a group of members to step up and provide the leadership for getting it done. This is a small challenge, given the caliber of our members. I look forward to seeing it happen. We will start the conversation in Utah.

Lastly, thanks to Clemente McWilliams for securing funds from Eli Lilly, Elanco Animal Health to sponsor the COSBAE reception, Tuesday, August 3, 1998, and Donald McDowell and Doris Newton for the development of the newsletter.

Spotlight on an Outstanding Black Agricultural Economist

Carlton G. Davis has compiled a record of excellence in research, teaching and professional service. His notable achievements in the study of human resource development, rural poverty, food and agricultural policy and international trade and development have been distinguished by scholarly excellence and focus on critical issues in the South. Dr. Davis, earned a Ph.D. degree in Agricultural Economics from Michigan State University, after earning a M.S. and B.S. in Agricultural Economics from the University of Nebraska, Lincoln. He has served as instructor, Michigan State University, and visiting professor, Department of Agricultural Economics and Farm Management, The University of West Indies, St. Augustine, Trinidad. For over 25 years, Davis has labored fervently in his chosen profession, agricultural economics. Nearly all of his professional career, 1970-present, has been spent at the University of Florida where he progressed from Assistant Professor to Distinguished Service Professor.

He has published extensively (books, journal articles, book chapters, monographs) on special interest topics of the South. His early work focused on poverty and rural underdevelopment in the United States and he has made significant contributions to the literature in this area, including his landmark book entitled, *Rural Poverty and the Policy Crisis*. He also contributed substantially to the AAEA landmark study on *Opportunities and Status of Blacks in the Agricultural Economics Profession*. Furthermore, he has been instrumental in making COSBAE (Committee on Opportunities and Status of Blacks in Agricultural Economics) a permanent and active committee of the Association.

Dr. Davis has been a member of the Governing Board of the AAEA Foundation and served on numerous committees including the Nominating Committee, International Committee and the SAEA Honorary Lifetime Membership Award Committee. He is a member of the editorial councils of the AAEA's *Review of Agricultural Economics and Farm and Business* - the Journal of the Caribbean Agro-economic Society.

Dr. Davis has received numerous professional honors and nation-wide recognition. He was the 1996 recipient of the Southern Agricultural Economics Association Lifetime Achievement Award. Dr. Davis was also recognized and received an award for "Outstanding Contributions to the Caribbean Student Community (July 1996) and Selected to the Master Program University of Nebraska-Lincoln, in their 1996 Master's Week Program. Selection of Masters is very competitive and provides an opportunity for outstanding alumni to share experiences and serve as role models for students. He has been and continues to be an important contributor to the United States and Caribbean agriculture. Carlton, you make us proud.

STUDENTS SPOTLIGHT
