A result of the meeting was the suggestion for the development of a Graduate Student Extension Award for the 2005 AAEA meetings. Guidelines for this award are being developed by a Committee consisting of Larry Sanders (Oklahoma State U. who suggested the award), Don Ricks (Michigan State University) and Margot Rudstrom (U. of Minnesota). A cash prize will be given to the student who best extends their thesis work to Extension/Outreach presentation and publication. Details on application and the competition will follow in future newsletters.

The business meeting was followed by an Extension Section Reception attended by about 80. The Center for Farm Financial Management (CFFM) was a co-sponsor of this event so please thank Kevin Klair and Bob Craven when you see them. Lowell Catlett gave the Extension Luncheon crowd of over 120 an entertaining as well as an informative talk about "Trends That Change Everything." At the luncheon, the Award for best Extension website was presented by Ron Plain to Penn. State University. Alabama A&M received honorable mention. Call for 2005 AAEA Extension Section Organized Symposiums

This is the first annual call to submit proposals for Extension Section Track Organized Symposiums to be presented at the 2005 AAEA meeting in Providence Rhode Island. Submitted proposals will be reviewed by the Section Board and four will be selected for presentation as part of the Extension Track. The deadline for submission is November 1, 2004. Presentations within a symposiums must all pertain to a topic or relate to a theme. Examples (and these are only examples) of such symposium themes might be aquaculture/mariculture outlook; urban agriculture; urban/rural ag. issues; agricultural tourism; water quality/resource issues; how to value extension/outreach programs; outlook for the next farm bill; etc.. If a symposium is not accepted as part of the Track, submitters will be notified in time to submit their proposals to the general AAEA competition.

Guidelines for Proposals:

Symposium proposals must be Extension or Outreach related. Presentations within the symposium should relate information or educational products that Extension/Outreach specialists can use or will be of value to them in their own programs. Submit your proposal electronically by November 1, 2004 to Sam Funk at funk@agecon.ksu.edu in Word© or pdf format. Include:

- Title.
- Names of organizers with addresses, phone #'s, fax #'s, and e-mail.
- ➤ Short Abstract (50 words max including figures, tables) briefly summarizing the symposium,
- Extended Abstract (1300 words max including figures, tables) giving a detailed description of the symposium and the
- Moderator, speakers and the title of each speaker's presentation.

A symposium is 90 minutes long. The last 30 minutes are usually reserved for discussion and audience participation.

Call for 2005 AAEA Track Papers, Pre/Post Conferences

The Denver meeting is over and now it's time to think about Rhode Island 2005. The AAEA Executive Board is soliciting proposals for Principal Papers, as well as Pre and Post Conferences, for the Rhode Island meeting. The deadline for these proposals was announced in the July/Aug. AAEA newsletter as November 1. The Extension Section would be glad to support papers and Pre and Post Conference Proposals as part of the track. However, principal papers included in the track sessions must go through the AAEA principal papers competition. Also, Pre and Post Conferences must be approved by the AAEA. According to the AAEA guidelines the criteria for selection is "continuous contribution" to the advancement of agricultural economics in research, teaching, extension, administration or business and membership in the AAEA for 10 years. Continuous contribution in the Extension context means "leadership in the development of extension programs extensively utilized by other professionals." In the context of business, government or NGO it means outstanding performance. Guidelines for submission are listed in the July/August AAEA newsletter. Deadline for submission is October 11, 2004.
